- Public Hearing on Tax Increase. Last year, the Webb County property tax rate was 0.420055. That rate raised \$62,285,578 in revenues, a portion of which was used to fund maintenance and operations such as for road and bridge, law enforcement, judicial functions, county government, health and welfare, recreation and culture, community service, and other sources and uses. This year, Webb County is proposing a property tax rate of 0.420055. That rate will raise \$67,697,982 which is \$5,412,404 more in revenues than that raised by taxes imposed last year.
