RESOLUTION

AUTHORIZING AND ESTABLISHING THE MAIN, TEMPORARY BRANCH, AND TEMPORARY MOBILE BRANCH EARLY VOTING POLLING SITES FOR THE MAY 27, 2014 JOINT DEMOCRATIC AND REPUBLICAN PRIMARY RUNOFF ELECTIONS WITHIN WEBB COUNTY, TEXAS, PURSUANT TO CHAPTER 85, TEXAS ELECTION CODE.

WHEREAS the Webb County Elections Administrator is the early voting clerk in a primary election; and

WHEREAS the provisions of Chapter 85, Texas Election Code, were enacted to maximize the opportunity for all of the people to exercise the right to vote; and
