All,

The 2014 Operation Stonegarden (OPSG) Grant Funding Opportunity Announcement (FOA) and Operations (Op) Order Template were recently released by FEMA/DHS. A copy of both is attached.

OPSG provides funding to designated counties/localities to enhance cooperation and coordination between federal, state, local, tribal, and territorial law enforcement agencies in a joint mission to secure the U.S. borders along routes of ingress from international borders to include travel corridors in states bordering Mexico and Canada, as well as states and territories with International water borders.

The date of **May 7, 2014**, has been set as the deadline all Op Orders (Initial Applications), must be submitted to the Texas Homeland Security State Administrative Agency (THSSAA) by US Customs and Border Patrol OPSG Representatives.

Please be aware that this deadline will affect any subsequent deadlines the US Customs and Border Patrol OPSG Representatives will be imposing to ensure that they receive Op Orders in a timely manner.

Note: It is imperative that eligible counties begin the process of preparing Operation Orders with detailed Annual Budget.

The Operations Order Detailed Budget must:

- Include operative spending plans in one-year increments for (Year 1 and Year 2).
- Explain how costs and expenses were estimated, and
- Provide a narrative justification for cost and expenses.
