Once property purchased with DOJ equitable sharing funds has fulfilled it's intended use, it may be transferred to another law enforcement agency for law enforcement use. Any proceeds from the sale of any official use or tangible property purchased with shared funds must be deposited into the agency's DOJ equitable sharing account and are subject to the same policies set forth in the Guide to Equitable Sharing.

The agency should maintain all records and receipts related to the transfer for a minimum of five years.
