### STATE OF TEXAS COUNTY OF WEBB

PROFESSIONAL SERVICES AGREEMENT BETWEEN WEBB COUNTY AND DESI A. VASQUEZ, PH.D. FOR THE 406TH DISTRICT COURT, DRUG COURT PROGRAM; TEXAS OFFICE OF THE GOVERNOR CRIMINAL JUSTICE DIVISION DRUG COURT GRANT FUND NUMBER DJ-09-AI0-2056407

This Contractual Agreement is made between the County of Webb, a political subdivision of Texas on behalf of the 406<sup>TH</sup> District, Judicial Adult Drug Court Program, hereafter referred to as "Webb County" and Desi A. Vasquez, Ph.D. (hereinafter referred to as "Psychologist")

### RECITALS

WHEREAS, Webb county through 406<sup>th</sup> Judicial District Adult Drug Court Program is authorized by Chapter 469 of title Texas Health and Safety Code to provide an alternative to traditional criminal sanctions for eligible participants of the Drug Court Program; and

WHEREAS, one of the goals of Webb County and the 406<sup>th</sup> Judicial District Adult Court Program is to assist participants of the Drug Court Program that require adequate mental health services; and

WHEREAS, Webb County desires to engage the services of an outside Psychologist to perform the services in this regard; and

WHEREAS, Desi A. Vasquez, PH.D. is capable of provided MH services and desires to render services for participants of Webb County 406<sup>th</sup> Judicial District Adult Drug Court Program on the terms and conditions provided herein; and

WHEREAS, this agreement complies with the funding requirements of the State of Texas, Office of the Governor,

NOW THEREFORE, Webb County hereby retains the services of Desi A. Vasquez, PH.D., as a Psychologist and agrees to render its services as follows:

### **SERVICES**

Desi A. Vasquez, PH.D. shall provide MH care; substance abuse screening, mental health assessment, group therapy, ten(10) parenting therapy sessions, twenty six (26) anger management therapy sessions, coaching, cognitive and life skills therapy sessions, substance abuse individual and group treatment/therapy recommendations;

### CONFIDENTIALITY

Any reports, information, data or studies given to or assembled by Psychologist under this agreement shall be kept confidential and shall not be made available to any individual or organization without prior written approval of Webb County, unless otherwise provided by law. Webb County and Desi A. Vasquez agree and acknowledge that all project patient information and records are confidential and may be disclosed and used only in accordance with Alcohol and Drug Abuse Patient Records Regulations, 42 CFR 2. Webb County and Desi A. Vasquez, PH. D. shall further comply with any and all regulations under the Health Insurance Portability and Accountability Act, the Program's Privacy Rules, and the Participants' Consent Rules.

### **TERM**

This agreement shall be in effect and shall commence on September 1, 2014 and shall terminate on August 31, 2015. Either party may terminate this agreement by giving thirty (30) days written notice to the other party.

### **COMPENSATION**

For services rendered hereunder Webb County will compensate Desi A. Vasquez, PH. D. an amount not to exceed fifteen thousand dollars (\$15,000.00). Webb County shall make monthly payments after Desi A. Vasquez, PH. D., has submitted and itemized request for payment, which shall include the nature of the services provided, to 406<sup>th</sup> Judicial District Adult Court Program.

### **INSURANCE**

In order to protect Webb County and 406<sup>th</sup> Judicial District Adult Drug Court Program; Desi A. Vasquez, PH. D. shall maintain a policy of professional liability insurance and shall further identify and hold Webb County harmless form any and all claims arising out of the performance of his/her duties under this agreement.

# **TERMINATION**

This contract may be terminated by Webb County at any time on 30 days written notice to Desi A. Vasquez, PH. D.

## **ASSIGNMENT**

Neither this agreement nor any duties or obligations hereunder shall be assignable by Desi A. Vasquez, PH. D. without prior written consent of Webb County.

# SUCCESSORS AND ASSIGNS

Subject to the provision regarding assignment, this agreement shall be binding on the heirs, executors, administrators, successors and assigns of the respective parties.

# **GOVERNING LAWS**

The validity of this agreement and any of its terms or provisions, as well as the rights and duties of the parties hereunder shall be governed by the laws of the State of Texas, Jurisdiction and venue for any action or claim arising out of this Agreement shall be in the Federal and/or State Courts of Webb County, Texas.

### INDEPENDENT CONTRACTOR

D. or any of its employees eligible for the fringe benefits, such as retirement, insurance and worker's compensations, which Webb County provides its employees.
