- Description of public utilities and service provider(s) (i.e. water wastewater, electricity, natural gas, telecommunications and cable). If not applicable, provide distance of nearest provider'
- 4. Price per acre.
- 5. Describe the property with topography, drainage, and any special issues regarding flooding or the special flood hazard area;
- 6. Provide detail with regarding jurisdictional issues related to municipal corporate limits or extra-territorial jurisdictions, if any;
- 7. Details with regard to plat status.
- 8. Details with regard to zoning status, if applicable.
- 9. Tax certificates showing evidence taxes are current for all applicable taxing entities.
- 10. Property location map.
