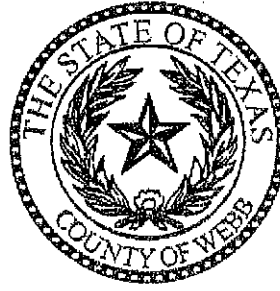
Please submit **ASAP** to ensure quick approvals and with the deadline for your purchase to be completed in SPARS by July 31.

Dear Mr. Silveira:


First of all, thank you for your efforts to assist the Webb County Sheriff's Office in better serving our constituents and enhancing border security along the Southern border of Webb County, Texas. Secondly, I am sending this justification to request the approval of the following items: maintenance for the skybox in the amount estimated at \$2,300 and ALPR equipment/installation in the amount of \$56,000. Due to the continuing utility of existing equipment during OPSG operations, the purchase of these two (2) proposed OPSG-funded items to enhance existing operations have been approved by the U.S. Border Patrol-Laredo Sector.

Currently, the skyboxes are used for security of the border areas and any other place that the Webb County Sheriff's Office deploys officers during OPSG operations. The systems are also used for deterrents, observations, and interdiction. Specifically, the funds will be used for upgrading the batteries and providing maintenance services so they can be in full working order.

Furthermore, the ALPR system will work with the current system that the Webb County Sheriff's Office possesses. The ALPR system gives the officers working OPSG operations the ability to monitor the cameras from a place with a working internet connection. The ALPR system is a mobile trailer that can also work in any area with an active wireless internet connection as well. The system will monitor any vehicles that are flagged in the TCIC/NCIC database. Moreover, the Webb County Sheriff's Office can also create a watch list for special investigations conducted during OPSG operations.
