This "Data Exchange Agreement" sets forth the roles and responsibilities, assumptions, scope, constraints and an estimated schedule that will govern the data exchange project detailed below. It is effective after the signing of this agreement by White Box Technologies Inc., a Utah corporation with its principal place of business at 1600 W 2200 S, SLC UT 84119 ("White Box"), and Webb County Tx, located at 1110 Washington St, Suite 304, Laredo TX 78040 (Webb). The content of this document is intended to provide framework for the data integration project processes, to ensure mutual understanding, clear expectations and successful results, and is subject to the terms below.

PROJECT SUMMARY: Using the Justware API and Tyler Technologies API, White Box will create a bi-directional data exchange for data sharing between Webb Justware installation, and Tyler Technologies Odyssey. Additionally, an out-going data exchange will be created from Tyler Technologies' Incode (TPS) database to Justware as well.

### Roles and responsibilities:

#### Webb

- Subject Matter Expert and IT Support
  - o Promptly answer technical and/or business operation questions
  - Review, test and provide feedback on field mapping, developed interchange and processes per schedule

#### White Box

- Project Manager
  - Manage project scope, schedule, and performance
  - o Coordinate integration activities with Webb
  - Work with Webb to resolve issues
- Data Engineer
  - Work with Webb to develop and write the integration rules and resolve issues identified during the construction, testing and go live

### Methodology:

White Box follows industry standard methodologies for all Development and Integration projects. For the Webb Justware API development project, Rapid Application Development Methodology (RAD) will be deployed. The primary goal for this integration project is to provide a high quality system with a key emphasis on fulfilling business requirements. As with any project, active user involvement is key in making for a successful completion. Rather than focusing on design and efficiency White Box focuses on resolving the issue. The project will be broken down into smaller segments with the aim to produce quality output with iterative prototyping.

Phases (Iterative for each segment)

- 1. Requirements Planning
- -White Box will meet with the County, Tyler Technologies and/or Journal Technologies as necessary via phone or GoToMeeting to discuss the requirements for the segment, discuss highest priorities and work out specific details which include; field mapping, connectivity and ensure expectations are set for all parties

#### 2. Construction

-In this phase the process is built, and tested with user involvement. As testing progresses and if new requirements are discovered during the testing phase that are within scope, the process begins again with the new requirements and the process of building and testing repeats until the segment is complete. Then White Box will proceed to the next segment.

### In Scope Service:

Utilizing Journal Technologies API toolkit/Database views, and the Tyler Technologies API/XML Files, White Box will develop a bi-directional data exchange interface between the Webb Justware Database and the Tyler Odyssey database

Triggers that define what and when Information will be exchanged, (updated or inserted) is outlined in the document Webb County Integration Scope and is made part of this SOW as Attachment A.. In addition, data to Justware from Incode/Tyler Public Safety will also be included as well as when the DA's Office disposes a charge, the disposition will be indicated in the booking data from Justware to Odyssey Jail Manager.

A definitive listing of fields to be exchanged between the interfaces will be established at the beginning of the project during the kickoff/requirements phase of the project and is expected to be no more than 75 total fields. Additional fields above that amount may be subject to a change request. At a minimum the following information will be exchanged/updated/inserted between the two systems:

### Assumptions and Constraints:

- White Box assumes all software, hardware and licensing costs are already accounted for including Journal Technologies API and the Tyler API. Hardware requirements will necessitate a network connection and access to the API for both systems. The computer the process is installed will need to be running windows (any version) with .NET 3.5 installed, 1 GiG of free hard drive space, and a 1.3 GHZ speed or faster CPU. Should any additional hardware, software or licensing be required to develop the data exchange or for the exchange to function properly, White Box will not be responsible for acquiring any additional hardware, software, licensing or fees
- It is assumed that all API documentation is straightforward and that no additional API training be required. It is understood that Tyler API training is available if needed through the Webb contract and White Box will be responsible for any travel related expenses for any additional training.
- Three test interface processes and one final iteration are included within the scope of the SOW.
- No Graphical User Interface (GUI) will be developed or created
- The interface will record any errors encountered in a log. Said log file must be human readable and include the data involved, the time and date of the error, and a description of the problem encountered. The interface will include a mechanism for re-submitting records causing errors after they are corrected. If an error occurs due to connectivity issues, the interface will automatically try to resend any records the next time it runs.
- WhiteBox will provide Webb County with a code table mapping utility to allow Webb County to maintain any
  code mappings between systems. The code table utility will allow Webb County to set a default code mapping
  for each table. Any time default codes are used an error should be written to the error log.
- It is assumed that the interface can communicate with both databases and that all API's and other required interfaces are available from the installation location
- Additional interfaces enhancements are not covered in this statement of work and any additional requirements that require adding or programming codes or fields, once the field mapping is complete, will require additional costs.
- Journal Technologies and Tyler will merely provide support on API questions and will assist White Box on API support questions. This agreement includes an annual maintenance agreement starting at the end of the 30 day warranty period. Maintenance agreement includes up to 20 hours of additional programming due to changes in network connection, database upgrades etc.or any additional features not part of the original scope, up to 20 hours of total effort. White Box guarantees a response time within 4 hours of logged issue. Anything beyond the 20 hours will be invoiced at \$150.00 hr,
- With any data exchange, duplicate entries may exist and any new entries may duplicate existing data. The success of the interchange depends heavily on the quality of the data being received. 100% elimination of duplicates is not guaranteed
- Webb will provide a primary point of contact(s) to review the application and be available to answer any technical or process questions.

- The data schema provided for development and the final interface must match exactly. Any changes made once development has begun will be subject to a change request.
- White Box will assist Webb in installing and loading the interface code
- Once project is complete, White Box will deliver a copy of the source code to Webb. Should any additional
  enhancements, upgrades, or customizations be required by Webb, White Box can provide a quote for those
  services. The code delivered is for the sole use of the County of Webb and cannot be resold or licensed to
  any other party.
- No data cleansing will be provided by White Box
- A project schedule will be jointly developed and mutually agreed to during the initiation of this project
- Work performed under this Statement of Work is under warranty by White Box for thirty (30) days following delivery of the data interchange code (period of performance). Errors or omissions in exchanged data that result from interchange process included with the agreed upon field mapping is covered by this warranty. Any changes to source data, database, API or additional data elements not originally agreed to in the field mappings are not covered under this warranty.
- Assuming there are still some moving parts to business processes and the implementation of Odyssey, there
  will be some changes to the scope of work. With this in mind, the project price will not change as long as the
  amount of fields being exchanged does not increase. Additional fields can be added according to pricing
  schedule below.

### Pricing Schedule:

To add additional fields the first 25 fields are priced at 3200.00 per block. If more than 25 fields are needed then pricing will be in the next band e.g. first 25 fields 3200.00 + next 25 fields =6200.00 total to add in 50 additional fields.

#### PARTY MATCHING

Before adding a name to the JustWare or Odyssey system, all interfaces shall attempt to locate and utilize an existing name in lieu of creating a new name. If an existing name is used, it shall be updated. Name matching shall be based on the following criteria (aka JustWare Level 1 name match):

Exact match on last and first name spelling. AND

Match the first character of the middle name and suffix. AND

Must have at least two matches on:

- o DOB
- o Social Security Number
- StateID Number
- o FBI Number
- o Driver License Number

-OR-

Match on Odyssey Name ID stored in JustWare

-OR-

Similar algorithm to prevent duplicate name records from being created in JustWare

After creating the case for a defendant based on a New Jailing Saved trigger, if another jailing is processed with the same arresting agency and arresting agency case number and different inmate/defendant, a new case shall not be created. Instead, the following shall be added to the existing JustWare case as described above:

- Booking Number (one jail agency involvement per defendant)
- Defendant case involvement with TRN and Arrest Date
- If no charge exists on the existing JustWare case with a matching combination of offense code and TRS, create a new charge record
- Defendant charge involvement
- Booking documents
- Magistrate court agency involvement, if different from existing
- Magistrate name involvement with for field populated with reference to new defendant
- Non-collectable financial bond record and associated bond involvement
