**RESOLUTION  
WEBB COUNTY COMMISSIONERS COURT**

A RESOLUTION OF THE WEBB COUNTY COMMISSIONERS COURT DECLARING THAT SAN IGNACIO ROAD BRIDGE, LOCATED 2.9 MILES EAST OF LOOP 20 ON SAN IGNACIO ROAD IS NO LONGER ON THE WEBB COUNTY ROAD SYSTEM. THIS BRIDGE IS ON THE NATIONAL BRIDGE INVENTORY (NBI) AND IDENTIFIED AS STRUCTURE NUMBER 22-24-0-AA03-11-001. THE BRIDGE IS LOCATED ON PRIVATE PROPERTY AND ACCESS TO THE BRIDGE IS BLOCKED BY A PRIVATE GATE WITH CLEARLY MARKED SIGNS WHICH STATE THE ROAD IS PRIVATELY OWNED.

WHEREAS, it is deemed expedient that Webb County maintain and improve county roads and bridges.

WHEREAS, removal of the bridge from the national bridge inventory is recommended.

NOW, THEREFORE, BE IT RESOLVED by the County Commissioners Court of Webb County, Texas:

That the San Ignacio Road Bridge, located 2.9 miles East of Loop 20 on San Ignacio Road, National Bridge Inventory, (NBI) Structure number 22-240-AA03-11-001 is located on private property. San Ygnacio Road Bridge is not part of the Webb County Road System.
