## AMENDMENT

The Webb County Commissioner's Court Head Start Program sponsors several school campus/a sites of Head Start classrooms located at Dovalina, Heights, Sanchez Ochoa and JC Martin elementary school campuses through Child and Adult Food Service Program for PM Snack only.

Through this agreement, it confirms that the Laredo Independent School District has given permission for the sponsoring organization, Webb County Commissioner's Court Head Start Program, to provide daily PM snack to the Head Start classrooms located specifically at Dovalina, Heights, Sanchez Ochoa, and JC Martin Elementary School campuses and claim reimbursement for PM snack only through the Child and Adult Food Program.

The Webb County Commissioner's Court Head Start program acknowledges the Laredo Independent School District will provide breakfast and lunch to the Head Start classrooms located at Dovalina, Heights, Sanchez Ochoa, and JC Martin Elementary School campuses through the National School Lunch Program and claim reimbursement for breakfast and lunch only effective August 23, 2015 until each agreement is terminated.

Please note that the Laredo Independent School District cannot provide the same services (PM Snack) as proposed to be provided by the Webb County Commissioner's Court Head Start Program to avert a conflict of interest and/or a possible non-compliance issue.
