**RESOLUTION AND ORDER  
WEBB COUNTY COMMISSIONERS COURT**

A RESOLUTION OF THE WEBB COUNTY COMMISSIONERS COURT APPROVING THE TEXAS TRANSPORTATION CODE, SECTIONS 201.103 AND 222.052 THAT ESTABLISHES THAT THE STATE SHALL DESIGN, CONSTRUCT, AND OPERATE A SYSTEM OF HIGHWAYS IN COOPERATION WITH LOCAL GOVERNMENTS;

**WHEREAS**, a Federal Highway Administration Category 10—Coordinated Border Infrastructure (CBI) Off-System project to undertake and complete a highway improvement generally described as providing Preliminary Engineering including Schematic and Environmental for the Hachar Road Extension called “Project” is currently approved as authorized by Texas Transportation Commission Minute Order Number 114417 Control-Section-Job (CSJ) Number 0922-33-166; and

**WHEREAS**, the Hachar Road is located between FM 1464 and I-35, Section: Northern N.D. Hachar Tract Boundary to I-35; and

**WHEREAS**, the usual fund participation ratio for projects on such program is 80 percent federal, 20 percent Local Government; and

**WHEREAS**, the estimated local match fund participation requirement on the approved project is \$60,000.00 (dollars); and

**WHEREAS**, the estimated local participation for state direct costs requirement on the approved project is \$15,000.00 (dollars); and

**WHEREAS**, the county is responsible for 100% cost overruns until the federal funding reaches the maximum obligated amount.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COMMISSIONERS’ COURT OF WEBB COUNTY, TEXAS:**

Approves the Texas Transportation Code, Sections 201.103 and 222.052 that establishes that the state shall design, construct, and operate a system of highways in cooperation with local governments.
