## **RFSOLUTION**

A RESOLUTION OF THE COMMISSIONER'S COURT OF WEBB COUNTY, TEXAS, AUTHORIZING THE SUBMISSION OF A CONTRACT AMENDMENT REQUEST FOR THE TEXAS COMMUNITY DEVEPOPMENT PROGRAM'S (TCDP) CONTRACT BETWEEN WEBB COUNTY COMMUNITY ACTION AGENCY (CAA) AND TEXAS DEPARTMENT OF HOUSING & COMMUNITY AFFAIRS (TDHCA) OFFICE OF COLONIA INITIATIVES (OCI), CONTRACT NUMBER 712003 (Self-Help Center Program).

WHEREAS, the County of Webb entered into a contract with the State of Texas to perform certain project activities; and

WHEREAS, unforeseen extenuating circumstances have changed projected goals and activities; and

WHEREAS, it is in the best interest of the County of Webb to submit a Contract Amendment to the Texas Community Development Program, Texas Department of Housing & Community Affairs (TDHCA), Office of Colonia Initiatives (OCI) to complete such activities.

NOW, THEREFORE, BE IT RESOLVED BY THE WEBB COUNTY COMMISSIONER'S COURT OF WEBB COUNTY, TEXAS:

The Webb County Commissioner's Court authorizes a contract amendment request to be submitted to the Texas Department of Housing and Community Affairs Program for the following proposed activities:

- 1. To increase the number of solid waste clean-up campaigns.
- 2. To increase the number of beneficiaries under the housing rehabilitation activity. (The number of homes to be rehabilitated will not be affected).
- 3. To reduce the number of homes to be assisted and beneficiaries under the Small Home Repairs (accessibility) activity.
- 4. To increase the number of homes to be assisted and beneficiaries under the New Construction activity.
- 5. To transfer funds between contract line items within the existing budget. (The total budget amount will not change).

- 6. To increase the number of classes to be carried out and the beneficiaries assisted under the Homeownership & Instructional Classes.
- 7. To increase the number of beneficiaries assisted under the Construction Skills Classes.
- 8. To increase the number of beneficiaries assisted under the Technology Access (Computer) Classes.

The Webb County Commissioner's Court directs and authorizes the Webb County Judge to execute all necessary documents as may be required to initiate and process this contract amendment request.
