**TITLE:** Custodian

## **JOB SUMMARY:**

The Custodian is directly responsible to the Supervisor of Custodial Services.

Performs a variety cleaning processes within Webb County; under the general direction of the Custodian Supervisor and in accordance with National, Federal, State, and City and County requirements.

## CHARACTERISTIC DUTIES AND RESPONSIBLITIES:

- Ensures that personal safety equipment is appropriately used during work processes as needed.
- Submits list of materials and supplies needed for maintaining a high standard of cleanness in their area of responsibility to the Custodian Supervisor.
- Burnishes, sweeps, mops, shampoos, and vacuums floors using broom, dust mop, wet mop and electric driven power tools such buffers, vacuum cleaners, wet surface vacuum cleaners, parking lot sweeper, etc.
- Applies cleaning solutions and floor finishes in accordance with manufacturer's recommendations.
- Remove trash from buildings and parking lots for proper disposal.
- Cleans and maintains assigned custodial equipment.
- Rearranges furniture accordingly to accommodate changes or events.
- Locks and unlocks doors as directed.
- Restocks supplies such as hand soap, floor finish, paper towels, toilet tissue, etc.
- Observe and insure that all safety precautions, rules and requirements are followed within his/her area of responsibility.
- Insure that chemicals within his/her area of responsibility are appropriately labeled and stored securely.
- Perform additional duties as assigned.
- Must be able to establish and maintain effective and harmonious communications with other departments as related to building maintenance.
- Must be able to maintain a pleasant and positive work attitude among co-workers.

## **QUALIFICATION STANDARDS:**

- Three years as a full time Custodian
- Eighth grade education and must have the ability to read, write, and follow written and oral instructions.
- Must have Texas Driver License.

#### **ESSENTIAL DUTIES:**

- Must be able to work beyond a normal workday and at varied work locations.
- Primary duties require working indoors and outdoors with exposure to all types of weather conditions.
- Also exposed to noise and vibration from operating machinery.
- Exposed to unpleasant odors and hazardous materials.

## PHYSICAL REQUIREMENTS:

- Must be able to sit, stand, bend, and climb for prolonged periods of time.
- Must be able to lift 30-50 lbs (food bags & boxes, files, and other small equipment or devices.
- Must be able to work outdoors as needed.

# OTHER REQUIRMENTS/INFORMATION:

- Drug and Alcohol Policy applies to this job. Pre-employment drug/alcohol testing, driver license and criminal background checks are required.
- This position is covered by Civil Service; therefore, is subject to the Civil Service Rules and Regulations in addition to all other Webb County Policies.

## **SUPERVISORY:**

- Must work under general supervision, except where standard enables the Custodian to proceed alone in routine work.
- Must insure that all Custodian helpers follow state, city, and county requirements and standards.
