

IT Technician Sheriff's Department

SD/7 Pay Grade: 14

JOB SUMMARY

This position provides technical support for the maintenance and utilization of the department's information technology systems.

MAJOR DUTIES

- Assists in setting up equipment for employee use; ensures the proper installation of cables, operating systems, and software.
- Trains users in the proper utilization of enterprise servers/applications.
- Troubleshoots and resolves PC, network connectivity, and other IT hardware/software issues.
- Monitors IT systems operations to ensure operability; troubleshoots and resolves problems.
- Researches system additions and upgrades; makes purchase recommendations.
- Manages the inventory of department IT equipment.
- Maintains printers and other peripheral devices.
- Installs, maintains and repairs radio communications equipment.
- Maintains electronic equipment and software on department vehicles.
- Researches, gathers data, and prepares reports, presentations and publications.
- Maintains and repairs the DVR camera monitoring system.
- Maintains the fingerprint identification system.
- Maintains and repairs telephone equipment.
- Consults with hardware and software vendors for troubleshooting and problem resolution.
- Perform any other duties as assigned.

KNOWLEDGE REQUIRED BY THE POSITION

- Knowledge of information technology systems and internal controls.
- Knowledge of information technology best practices.
- Knowledge of relevant local, state and federal laws.
- Knowledge of customer service and end user support procedures.
- Skill in the analysis of problems and the development and implementation of solutions.
- Skill in the preparation of clear and precise reports.
- Skill in oral and written communication.
- Ability to communicate in English and Spanish.

SUPERVISORY CONTROLS

The Sergeant assigns work in terms of general instructions. The supervisor spot-checks completed work for compliance with procedures, accuracy, and the nature and propriety of the final results.

Guidelines include information technology best practices and county and department policies and procedures. These guidelines are generally clear and specific, but may require some interpretation in application.

COMPLEXITY/SCOPE OF WORK

- The work consists of related technical duties. Frequent changes in technology contribute to the complexity of the position.
- The purpose of this position is to provide technical support for the operation and maintenance of the department's IT system. Success in this position contributes to the efficiency and effectiveness of county operations.

CONTACTS

- Contacts are typically with co-workers, other county personnel, vendors, and members of the general public.
- Contacts are typically to provide services, to give or exchange information, or to resolve problems.

PHYSICAL DEMANDS/ WORK ENVIRONMENT

• The work is typically performed while sitting at a desk or table or while intermittently sitting, standing, stooping or walking.

• The work is typically performed in an office.

SUPERVISORY AND MANAGEMENT RESPONSIBILITY

MINIMUM QUALIFICATIONS

- Knowledge and level of competency commonly associated with completion of specialized training in the field of work, in addition to basic skills typically associated with a high school education.
- Sufficient experience to understand the basic principles relevant to the major duties of the position, usually associated with the completion of an apprenticeship/internship or having had a similar position for one to two years.
- Must have a high school diploma or GED from an accredited institution.
