On behalf of the Texas Veterans Commission, I would like to congratulate your organization again on receiving a General Assistance–16A grant and notify you of a special opportunity for an amendment to extend your grant and gain additional funding.

The Fund for Veterans' Assistance (FVA) General Assistance grant program is transitioning to a single funding cycle per year beginning with the 2017-2018 grant cycle. In order to smooth the transition for our grantees the Texas Veterans Commission set aside an additional \$2,000,000 for General Assistance–16A grants only. Your organization has the opportunity to request up to a six month extension and up to 50% additional funds through the normal amendment process.

The Commissioners indicated that they will weigh grantee's performance heavily when assessing these amendment requests so I strongly encourage you to jump on your GA-16A grant project early to ensure you are meeting your performance and expenditure benchmarks on your quarterly reports.
