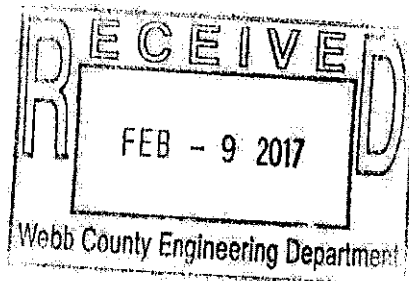

In the cover letter for the proposed agreed order mailed out to Webb County on November 3, 2016, Webb County was given an opportunity to propose a Compliance Supplemental Environmental Project ("C-SEP") to offset the payable penalty. Your proposed C-SEP has been reviewed and has been incorporated in the enclosed revised proposed agreed order. The Economic Benefit Worksheet for Violation No. 1 on the Minor Source Penalty Calculation Worksheet ("PCW") and the technical requirements within the proposed agreed order were adjusted for the incorporation of the C-SEP.

Enclosed for your convenience is a return envelope. **If the signed order is not mailed and postmarked within two weeks of the date of this letter**, we will assume that you have elected to participate in the more extended enforcement process described in previous correspondence, and we will proceed accordingly. Your case will be forwarded to the Litigation Division and this settlement offer, including the penalty deferral and possibly the C-SEP, will no longer be available.
