CONSENT AGENDA: At most meetings, the Commissioners Court establishes a Consent Agenda. Solution: The contribution will provide funding for energy assistance payment to Reliant Energy customers under the CARE program.

Result: Webb County Community Action Agency will accept enrollment applications from potential clients and qualify Reliant Energy Care program requirements.

c. Discussion and possible action to accept grant award Contract Number #61170002691 for the PY-2017 Community Services Block Grant Program (CSBG) State Discretionary Funds from the Texas Department of Housing and Community Affairs (TDHCA) in the amount of (\$16,250.00) SIXTEEN THOUSAND TWO HUNDRED FIFTY DOLLARS, and authorizing the County Judge to sign all relevant documents.
