# **Employee Benefits Assistant**

## **JOB SUMMARY**

This position is responsible for providing clerical support for the county's employee benefits functions.

#### **MAJOR DUTIES**

- Examines and processes personnel management documents.
- Answers telephone and greets visitors; provides information and assistance; refers to appropriate personnel.
- Coordinates special events and open enrollment for benefits.
- Schedules meetings and activities.
- Maintains inventory of office supplies; makes purchases as needed.
- Maintains department files and records.
- Makes copies and scans documents.
- Prepares new employee orientation packets.
- Performs any other duties as assigned.

## KNOWLEDGE REQUIRED BY THE POSITION

- Knowledge of modern office practices and procedures.
- Knowledge of county and departmental policies and procedures.
- Knowledge of computers and job-related software programs.
- Skill in prioritizing and organizing work.
- Skill in the use of such office equipment as a computer, scanner, fax machine, and copier.
- Skill in oral and written communication.

• Ability to communicate in English and Spanish.

## SUPERVISORY CONTROLS

The Employee Benefits Administrator assigns work in terms of general instructions. The supervisor spot-checks completed work for compliance with procedures, accuracy, and the nature and propriety of the final results.

## **GUIDELINES**

#### COMPLEXITY/SCOPE OF WORK

- The work consists of related clerical duties. Frequent interruptions contribute to the complexity of the position.

- Contacts are typically to give or exchange information, resolve inquiries, and provide services.

- The work is typically performed while sitting at a desk or table or while intermittently sitting, standing, stooping, or walking.
- The work is typically performed in an office.
