# Webb County Commissioner Court (Grantee) Webb County Head Start

## Texas School Ready Comprehensive 2017-2019 Grant

#### I. Proposal Summary

With the Texas School Ready (TSR) Comprehensive Grant, the Webb County Commissioners Court (Grantee) - Webb County Head Start will be able to serve the community by providing the following Comprehensive Services. When delivered together, these services and materials have been proven to have a positive impact on the instructional practices of early childhood teachers and the school readiness of children in their classroom: Professional Development, Coaching, Child Progress Monitoring, Classroom Curriculum and Materials. Since its inception in 2003, the program now known as TSR Comprehensive has served over 475,000 children across the state of Texas with close to 1,500 teachers participating each year. Multiple research studies have confirmed that TSR Comprehensive positively impacts teacher instructional practices in the classroom, regardless of setting (public school pre-k, Head Start, and private child care classrooms). Children's Learning Institute (CLI) is seeking Texas communities to help at-risk preschool children be better prepared for kindergarten. The TSR Comprehensive field staff will be responsible for the implementation of the project goals set by CLI and Webb County Commissioners Court (Grantee) - Webb County Head Start. We have a current list of 48 preschool teachers ready to be serviced by the Webb County Commissioners Court - TSR community under the TSR!Project. These Teachers and Schools were previously part of another TSR!Project in Laredo, Texas that was not able to reapply for the Grant this time.

The total for the TSR Comprehensive Grant is \$168,920 this includes salaries and fringe benefits, mileage, along with other areas detailed in the budget breakdown below.

#### II. Budget

Note: Finalized project reimbursement information will be sent to all Lead Agents after awards are announced.

#### • Office Space/Equipment Supplement:

CLI will supplement up to \$2,400 a year per full time field staff to the Lead Agent for office space and equipment provided.

• <u>Supplement of the organizational leader assigned to communicate with TSR management team on support and monitoring of TSR Project Implementation:</u>

CLI will reimburse the Lead Agent up to \$4,000 per year for leadership time and effort, including hosting community meetings, regular meeting with project staff, responding to reporting surveys, recruitment, outreach, and other administrative efforts. Reimbursement may be made twice a year (\$2,000 each in mid-year and end-of-year)

Webb County Commissioners Court (Grantee) – Webb County Head Start, has decided to opt out of this reimbursement and will transfer the funds to TSR field staff in a --- account to use for the needs of the community teachers participating in CDA process and any training materials needed.

• Salary and Fringe of the TSR field staff (project coordinators and coaches):

\$87,550 - Full Time Coordinator (1)

\$66,950 - Full Time Coach (1)

• <u>Mileage reimbursement for TSR staff's local travel:</u>

CLI will cap the mileage reimbursement of \$6,000 per field staff. (Schools which are over 50 miles away should be considered for a remote model.

Office and training supplies:

CLI will reimburse up to \$500 per full time field staff per year in purchasable of consumable supplies to be used in the office and for training.

• Additional reimbursement requests:

Lead Agents may request additional funding to reimburse for program costs they have incurred above the previously outlined reimbursement package.

Webb County Commissioners Court (Grantee) – Webb County Head Start is not requested any additional reimbursement or funding at this time.
