RESOLUTION AND ORDER

AUTHORIZING AND ESTABLISHING THE MAIN AND TEMPORARY BRANCH EARLY VOTING POLLING SITES FOR THE NOVEMBER 7, 2017 SPECIAL ELECTION PURSUANT TO CHAPTER 85, TEXAS ELECTION CODE.

WHEREAS the provisions of Chapter 85, Texas Election Code, were enacted to maximize the opportunity for all of the people to exercise the right to vote; and

WHEREAS the Commissioners Court of Webb County, Texas desires to establish polling places for the early voting period which will run from Monday, October 23rd through Friday, November 3rd for the **November 7, 2017 Special Election** in accordance with Chapter 85, Texas Election Code; and

WHEREAS the Commissioners Court of Webb County, Texas believes that the processes of our government work best when the people participate in the election process; therefore

BE IT RESOLVED by the Commissioners Court of Webb County, Texas that in order to maximize access to the polls, the following early voting sites are approved and established for the early voting period of the **November 7, 2017 Special Election**:

SECTION 1. MAIN EARLY VOTING SITE. The main early voting site required under Section 85.002 (b), 85.005 (c), and 85.006 (e), Texas Election Code, shall be established as follows:
