Issue: Contract needed for uniform supply for the Sheriff's Office.

Solution: Approve ITB 2017-004 to lowest and responsible bidder, Kirkpatrick Guns and Ammo.

Result: Secure fixed pricing on uniform orders and comply with annual CBA uniform purchase obligations.


