Result: Generate revenue from sale of property, reduce County expenditures by transferring surplus property to other departments and make room for future assets turned in by County departments.

Issue: Low bid for 2 of the project homes (Recon 01 & Recon 03) exceeded the allowable project grant budget of \$50,000.00 per home. Low bid for 1 of the project homes (Recon 02) was below budget but Contractor pulled their bid due to miscalculations on contractors part, the next lowest bidder exceeded project budget.
