


WHEREAS, the District Judges in and for Webb County, Texas, Joe Lopez, 49<sup>th</sup> District Court Judge, Monica Z. Notzon, 111<sup>th</sup> Judicial District Court Judge, Rebecca "Beckie" Palomo, 341<sup>st</sup> Judicial District Court Judge, and Oscar J. Hale, Jr., 406<sup>th</sup> Judicial District Court Judge, pursuant to law and in compliance with Sec. 84.002 of the Local Government Code, hereby appoint **RAFAEL PEREZ** as the Auditor in and for Webb County, Texas, effective MARCH 30, 2018, to fill the unexpired term 2017 through January 2019, with an annual compensation of One Hundred Thirty-Nine Thousand and No/100ths (\$139,000.00), to perform and discharge the duties of that office as the law directs and provides, after first having duly filed and posted his Oath of Office and Bond as the law directs and provides; and


**IT IS THEREFORE ORDERED AND DECREED** that **RAFAEL PEREZ** should be, and is hereby designated and appointed as the Auditor in and for Webb County, Texas, effective MARCH 30, 2018, to fill the unexpired term 2017 through January 2019, with an annual compensation of One Hundred Thirty-Nine Thousand and No/100ths (\$139,000.00), to perform and discharge the duties of that office as the law directs and provides, after first having duly filed and recorded his Oath of Office and Bond as the law directs and provides.


**IT IS FURTHER ORDERED** that the District Clerk of Webb County, Texas, **SHOULD AND SHALL RECORD** the original of this Order of Appointment of the Webb County Auditor in the minutes of the District Clerk's office and shall further, duly forward a certified copy of this Order to the County Judge and Commissioners of Webb County to be recorded in the minutes of their Court.




