ASSUMPTIONS AND QUALIFICATIONS

We have based this proposal on the best available information at the time provided by the Rio Bravo Water District. Existing manhole and pipe deterioration in excess of the conditions assumed, ground water loads in excess of those assumed, or other loads or conditions may increase the recommended design thickness for all or portions of the work. Final recommendations may be submitted to you following the completion of the preliminary inspection phase of the project conducted just prior to actual construction. Stated prices are subject to adjustment if the most recent conditions observed require design changes and are agreed upon.

Southern Trenchless Solutions, LLC. can supply the Rio Bravo Water District, Payment and Performance Bonds upon request and add the cost to the pay items contained herein. Certificate of Insurance shall be provided in accordance with the General Conditions of the City.

The pricing in this proposal assumes that all Technical Specifications set forth by the BuyBoard will be strictly adhered to and shall be subject to the specifications previously provided by the Rio Bravo Water District. A dumpsite shall be provided at no cost to **Southern Trenchless Solutions, LLC.** for the appropriate disposal of debris removed from the manholes and pipe. Water shall be provided at no cost to **Southern Trenchless Solutions, LLC.** for all construction phases of this project. **Southern Trenchless Solutions, LLC.** will follow all required deposit, blackflow prevention, and metering procedures. No provision for Bypass pumping is included herein. No provision for traffic control, other than cones, is included herein. Additional items for bypass pumping and traffic control can be provided upon request.

Proposal Terms and Conditions

Terms and Conditions from the Texas Statewide Purchasing Cooperative Contract are available upon request from the BuyBoard however shall be subject to the terms and conditions as provided by the Rio Bravo Water District. Any changes to these conditions must be noted and agreed upon by both parties. Any changes to the terms, conditions and specifications not previously provided to **Southern Trenchless Solutions, LLC** must be noted and agreed upon by both parties prior to execution.
