Correcting Commissioner's Court Minutes of September 10, 2018

WHEREAS, the Commissioners Court has reviewed the Official Minutes for Webb County Commissioner's Court Meeting, Monday, September 10, 2018 at 9:00 a.m. concerning item No.38 38A, and 39 which read as follows:

- 38. Discussion and possible action to adopt the county budget for fiscal year 2018-2019 pursuant to Chapter 111 of the Texas Local Government Code. The Court may make any modifications to the proposed budget that it considers warranted by law and required by the interest of the taxpayers by majority vote.
- 38.(A) Discussion and possible action to itemize and set fees by Order as part of the Fiscal Year 2018-2019 budget preparation process for the county's floodplain management program including but not limited to determinations, development permits, certifications and inspections as prescribed by the provisions of Section 16.324, Texas Water Code.
- 39. Discussion and possible to ratify, adopt and approve the property tax revenue increase reflected in the proposed budget that required raising more revenue from property taxes than in previous year as required by Texas Local Government Code 111.068, and executing an Order adopting the property tax rate for fiscal year 2018-2019.

WHEREAS, the video recording of the Webb County Commissioner's Court Meeting of, Monday, September 10, 2018 was reviewed; and

WHEREAS, after a review of the aforementioned video recording, the Commissioner's Court has determined that the Official Minutes for Webb County Commissioners Court Meeting, Monday, September 10, 2018 at 9:00 a.m. inaccurately reflect:

- (1) That action was taken by the Court concerning Item 38 A while Item 38 was being discussed.
- (2) While discussing Item 38, the minutes inaccurately reflect that a Motion by Commissioner, Pct. 3, John Galo, seconded by County Judge Tano E. Tijerina was to adopt the proposed budget, and
- (3) The minutes inaccurately reflect that after action was taken on Item 38, that discussion and action was taken on Item 39.

THEREFORE, BE IT ORDERED, ADJUDGED and *DECREED* by the Commissioners Court of Webb County, Texas that the Official Minutes for Webb County Commissioners Court Meeting, Monday, September 10, 2018 at 9:00 a.m. reflect:

- (1) That no action was taken on Item 38(A) while the Court was discussing and acting on Item 38.
- (2) That the motion concerning Item 38 made by Commissioner Galo, Pct. 3, and seconded by County Judge Tano E. Tijerina was to adopt the proposed budget as a base.
- (3) That after action was taken on Item 38, discussion and action was taken on Item 38(A).

The Commissioner's Court further **ORDERS** the minutes, attached hereto as Exhibit A, are the corrected official minutes of the Webb County Commissioner's Court of Monday, September 10, 2018.
