**CONFIRMING THE COMMISSIONERS COURT ACTION OF JULY 22,
2019 TO ENTER INTO AN INTERLOCAL AGREEMENT WITH THE
STATE OF TEXAS BY AND THROUGH THE TEXAS DEPARTMENT
OF MOTOR VEHICLES FOR THE PROVISION OF EQUIPMENT AND
CONSUMABLES TO THE WEBB COUNTY TAX
ASSESSOR/COLLECTOR**

WHEREAS, the State of Texas, by and through the Texas Department of Motor Vehicles (the "Department") is statutorily responsible for administering motor vehicle titles and registration; and

WHEREAS, the Webb County Tax Assessor/Collector acts as agent for the Texas Department of Motor Vehicles in the administration of motor vehicle titles and registration; and

WHEREAS, Texas Transportation Code §502.040 provides that an application for vehicle registration is made through the county Tax Assessor/Collector; and

WHEREAS, the Department maintains an automated system for the uniform administering of motor vehicle titles and registration, hereinafter identified as the automated registration and title system (RTS); and

WHEREAS, equipment is necessary for the processing of motor vehicle titles and registration; and

WHEREAS, the Department and Webb County desire that equipment procured by the Department, hereinafter identified as the "equipment," be installed and operated at location(s) under the jurisdiction of Webb County; and

WHEREAS, associated policies and procedures for Webb County use of the equipment are found in the department's County Equipment Guide and in Title 43, Texas Administrative Code (TAC), Sections 217.71-.74; and

WHEREAS, the Department will furnish the equipment to Webb County provided Webb County agrees to adhere and comply with the County Equipment Guide and the requirements established in this agreement; and

WHEREAS, the Department provides Webb County with certain consumable materials that are integral to the administration of motor vehicle titles and registrations, including disabled

placards, cardboard tags, forms, license plates, registration sticker paper, toner cartridges, registration receipt paper, department ad campaign supplies, and other materials (hereinafter referred to as "consumables"); and

WHEREAS, the Department and Webb County are authorized to enter into Interlocal contracts or agreements under the authority of Texas Government Code, Chapter 791;

NOW, THEREFORE, BE IT RESOLVED BY THE WEBB COUNTY COMMISSIONERS COURT THAT:

- Section 1: Confirms that on July 22, 2019 it did vote to enter into an Interlocal Agreement with the State of Texas, Texas Department of Motor Vehicles, for equipment procured by the Department to be installed and operated at location(s) under the jurisdiction of Webb County ; and
- Section 2: The Texas Department of Motor Vehicles will additionally provide Webb County with certain consumable materials that are integral to the administration of motor vehicle titles and registrations, including disabled placards, cardboard tags, forms, license plates, registration sticker paper, toner cartridges, registration receipt paper, department ad campaign supplies, and other materials; and
- Section 3: Webb County agrees to adhere and comply with the County Equipment Guide and the requirements established in this Interlocal Agreement.
- Section 4: The Commissioners Court directs that this Resolution be included with the Interlocal Agreement.
