Under Section 638 of the Head Start Act, this grant action awards WEBB, COUNTY OF a project period of 09/01/2019-08/31/2024 for the operation of Head Start and Early Head Start programs in the designated service area(s). This grant action awards \$9,444,405 for Head Start operations; \$111,605 for Head Start training and technical assistance; \$946,402 for Early Head Start operations; and \$21,756 for Early Head Start training and technical assistance for the initial budget period of 09/01/2019-08/31/2020.

Head Start population: 1,218 children.

Designated Head Start service area(s): Webb County (Laredo, Rio Bravo, and El Cenizo).

Approved program option(s) for the Head Start program: Center-based.

Early Head Start population: 72 infants, toddlers, and pregnant women.

Designated Early Head Start service area(s): Webb County (Laredo, Rio Bravo, and El Cenizo).
