Discussion and possible action to levy a property tax rate of \$0.412000 per \$100 taxable value by Order, under the provisions of Article VIII, Sections 9(a) and 9(b) of the Texas Constitution and Section 26.05 of the Tax Code for tax year 2019. The maintenance and operation tax rate will be \$0.376767 per \$100 valuation of which \$0.358483 will be for the general fund and \$0.018284 will be for road and bridge fund. The debt service rate will be \$0.035233 per \$100 valuation of which \$0.034550 will be for general fund debt and \$0.000683 will be for road and bridge debt.
