- 3.** Discussion with possible action regarding the imminent threat to public health and safety as a result of the spread of the Coronavirus (COVID-19), as declared by the World Health Organization as a pandemic on March 11, 2020. Matters to be discussed are as follows:
 - Suspension of all County-related travel for a period of thirty (30) days.
 - Suspension of all Community Center services for a period of thirty (30) days.
 - Discussion by Judge Joe Lopez, Administrative Judge, regarding the suspension of civil and criminal trials and jury duty.
 - Authorize Emergency Management Coordinator and Risk Management Director to develop policies that address epidemics and/or pandemics.
 - Retain the professional services of a cleaning and custodial company to assist the County's Building Maintenance Department in sanitizing all county buildings to reduce the exposure of germs and airborne viruses; and any other matters indicent thereto.
