# COUNTY TRANSPORTATION INFRASTRUCTURE FUND GRANT AGREEMENT

#### **AMENDMENT #2**

**THIS AMENDMENT** is made by and between the State of Texas, acting through the Texas Department of Transportation, called the State, and <u>Webb County</u>, acting by and through its duly authorized officials, called the County.

#### WITNESSETH

**WHEREAS**, the State and the County executed an agreement on May 29, 2014 to effectuate their agreement for transportation infrastructure projects located in areas of the state affected by increased oil and gas production; and,

**WHEREAS**, the State and the County executed Amendment#1 on June 21, 2019 to extend the contract time by 18 months; and,

WHEREAS, it has become necessary to amend that agreement;

**NOW THEREFORE**, in consideration of the premises and of the mutual covenants and agreements of the parties, the State and the County do agree as follows:

#### AGREEMENT

#### 1. Description of Amended Items

**A. Section 3. List of Transportation Infrastructure Projects** of the original agreement is deleted in its entirety and replaced with:

The State has authorized the County to include additional projects under the program. A revised project list has been approved and made part of this agreement as Attachment A-2. No further additional projects shall be authorized to the project list.

**B.** Section 4. b, Project Sources of Funds, and Reimbursement of the original agreement is deleted in its entirety and replaced with:

The County shall submit monthly billing statements or a statement that no construction or maintenance work was performed during the previous month, in accordance with procedures defined by the State, accompanied by a certification of work performed during the previous month. Along with the billing statements submitted by the County, it shall submit copies of all paid invoices and/or force account documentation. The County shall submit its final invoice to the State on or before May 14, 2021. No reimbursement will be paid to the County for invoices submitted after May 14, 2021. Within thirty (30) days of receipt of a complete billing statement and supporting documentation, submitted on or before May 14, 2021, the State will reimburse the County.

**C.** All other terms and conditions of the above-numbered agreement not hereby amended remain in full force and effect.
