On March 16, at the Attorney General's request, Gov. Section 418.016 (Vernon 2017). The Governor suspended provisions of TOMA that require a quorum of the governing body and the general public to be together in a single location in order to allow videoconference or telephonic meetings.

9. <u>Civil Legal Division</u>

a. Discussion and possible action to enter into Amendment #2 to the County Transportation Infrastructure Agreement Fund Grant for 2014 allowing the County to add additional projects to the program and requiring all invoices for reimbursement to be submitted on or before May 14, 2021 and any other matters incident thereto; authorizing the County Judge to sign all agreements and relevant documents.

10. Community Action Agency

a. Issue: Ten percent (10%) of the new construction project amount is held in retainage from the contractor for 30 days from the completion date of each project to ensure that any deficiencies which may arise are addressed by the contractor. Contract amount is \$75,000 and 10% retainer is \$7,500.

Solution: Commissioners Court authorizes the release of the retainer funds to the contractor.

Result: The contractor will be paid for services rendered.

b. Discussion and possible action to authorize the release of the 10% retainer payment to Romo Contractors, in the amount of \$5,392, contingent upon passing the final inspection and completion of the required 30 day waiting period for project located at 7379 Adelita Rd., San Carlos I. This action will not impact the County's General Fund. [Account #2530-206000]

Issue: Ten percent of the housing rehabilitation project is held in retainer for 30 days from the completion date of each project to ensure that any deficiencies which may arise are addressed by the contractor. Contract amount is \$53,920.00 and 10% retainer amount is 5,392.00.

Solution: Commissioners Court authorizes the release of the retainer funds to the contractor.

Result: The contractor will be paid for services rendered.

c. Discussion and possible action to approve Holding Institute as Representative Organization for Category "C" for Webb County Community Action Agency Advisory Board; and any other matters incident thereto.

Issue: State mandates the filling of vacancies when applicable term ends as per Administrative Code Chapter 5 Rule 5.215.

Solution: Vacancies will be filled.

Result: The Agency will comply with TDHCA- Texas Administrative Code, Chapter 5 Rule 5.215.

11. Honorable Isidro Alaniz, District Attorney

a. Discussion and possible action to authorize the transfer of a 2015 Chevy Tahoe (VIN: 1GNLC2EC3FR610859) Unit No. 0982 from the District Attorney's Office to the Webb County Community Supervision and Corrections Department in accordance with the Webb County Purchasing Policy, Section 4.1 Inventory Policy and Procedures (e.) transfer, and any other matters incident thereto.

Issue: The Webb County Community Supervision and Corrections Department is in need of a reliable vehicle for its Absconders unit. The vehicle will be used to apprehend offenders with outstanding arrest warrants and to locate offenders that do not report to their supervision officers as scheduled.

Solution: Approve the transfer of the 2015 Chevy Tahoe.

Result: The Webb County Community Supervision and Corrections Department will get additional law enforcement resources to continue its efforts in apprehending offenders with outstanding arrest warrants and to locate offenders that do not report to the supervision officers as scheduled.

12. Economic Development

a. Discussion and possible action to apply for the FY 2021 - 2022 CARES Act Grant Round 2 for Webb County Community Action Agency from The Texas Department of Transportation (TxDOT) in the amount of SIX HUNDRED THIRTY TWO THOUSAND THREE HUNDRED TWENTY EIGHT DOLLARS (\$632,328.00). This grant does NOT require a County Match. All required documentation has been submitted for review to the Economic Development Department and the solicitation is compliant with Webb County Single Point of Contact (SPOC) procedures. No impact to the General Fund. [Requested by James Flores, CAA Executive Director]

Issue: TxDOT has allotted monies as part of the COVID19 Emergency Relief Response in order to cover operational expenses, capital expenses and resilience projects at 100% for Webb County CAA- El Aguila Rural Transportation with NO County Match.

Solution: This grant is calculated to cover expenses for CAA El Aguila from January 1, 2021 through December 31, 2022.

Result: Continuation of transportation services throughout the rural areas of Webb County allowing for safe and reliable response to the transportation needs of rural Webb County during the on going COVID-19 pandemic.

b. Discussion and possible action to authorize the submission of a grant application for the Fiscal Year (FY) 2020 Operation Stonegarden (OPSG) as prepared and submitted by the Webb County Sheriff's Office to the Office of the Governor Homeland Security Grants Division in an amount estimated at \$2,249,244 for overtime, associated fringe benefits, equipment, supplies, fuel, helicopter maintenance/fuel, vehicle/tire maintenance, data services, Management & Administration (M&A), and maintenance of OPSG-acquired assets for local law enforcement agencies; and any other matters incident thereto. There is no cash match; and, thus, no cost to Webb County. All required documents were sent for review through the Economic Development Department and the solicitation is compliant with the Webb County Single Point of Contact (SPOC) procedures. [Requested by Martin Cuellar, Webb County Sheriff]

Issue: Complex and dynamic law enforcement challenges exist in the Southwest border area of the United States, including Laredo/Webb County. For example, transnational criminals seek to exploit existing law enforcement jurisdictional boundaries by conducting their illegal enterprises across traditional jurisdictional divisions. The 2014 Texas Gang Threat Assessment expounds, "Gang activity remains widespread throughout all regions of Texas...Gang activity is also prevalent in the Texas counties adjacent to Mexico and along the key smuggling corridors, since Texas-based gangs are used for cross-border smuggling and trafficking in the state. Many transnational gangs operating in Texas....engage in criminal activity in Mexico as well as in Texas and elsewhere" (Texas Department of Public Safety April 2014).

Solution: Grant application: (1) to ensure first responders are equipped with enhanced tools/equipment/resources needed to confront well-funded criminal organizations and (2) for the coordination of law enforcement efforts between various local and federal law enforcement agencies.

Result: Enhanced capabilities of local law enforcement responders; further coordination of response across local and federal jurisdictions.

c. Discussion and possible action to rescind action taken by Commissioners Court on January 25, 2021, Item #12 (i) under the District Attorney Isidro Chilo Alaniz; and further approve the submission of a grant application to the Office of the Governor Public Safety Office Criminal Justice Division for a County Innovations Grant estimated at \$250,000 over the term of the contract. The County Attorney's Office along with the District Attorney's Office will utilize this funding opportunity to prevent, investigate, and/or prosecute the commercial sexual exploitation of people in Texas. This formal request shall authorize the County Judge to act as the County's Executive Officer and Authorized Representative in all matters pertaining to the County's participation in this grant. There is no cash match requirement for this grant. All grant documents were sent for review through the Economic Development Department and the solicitation is compliant with the Webb County Single Point of Contact (SPOC) procedures. Contract term: October 1, 2021, to September 30, 2022. [Requested by Marco Montemayor, County Attorney]

Issue: There is a need for resources to address the issue of sexual exploitation in our community. Persons who have suffered abuse in childhood or adolescence are susceptible to being sexually trafficked or exploited. There is a need to train those

involved in the criminal justice system on how to identify potential and current victims and stop the cycle of exploitation. The Office of the Governor of Texas has provided available resources through a grant opportunity to enhance awareness, intervention and prevention of this serious issue.

Solution: Authorize the submission of the grant application as set forth above to ensure that the County Attorney's Office, District Attorney's Office, CPS Court and 406th District Court may create a diversion program for potential and current victims of sexual exploitation.

Result: The County Attorney's and District Attorney's Office will have the opportunity to receive additional resources to continue its work in identifying and fighting for victims of sexual exploitation. This will also result in a reduction of criminal activity related to sexual exploitation in our community.

Issue: A title search is needed to determine and confirm property ownership for residents in the Colonias who will donate a roadway. Right of Way and Public Utility Easement.

Solution: Make funds available to hire a professional to do said work.

Result: A clean title which is required for any modifications and/or construction.

14. Fire Suppression & EMS Services

a. Discussion and possible action to authorize Webb County Fire with the assistance of the Economic Development Department to develop and submit a U.S. Department of Homeland Security, FY 2020 Assistance to Firefighters Grant for up to \$200,000.00, for new personal protective equipment to outfit 30 additional firefighting personnel, hoses for fire trucks, and a removable skid for a military vehicle; and authorizing the County Judge to act as the Authorized Representative in all matters pertaining to the County's request for Assistance to Firefighters Grant Program funding. This application requires a five percent (5%) cash match should the application be funded, amount shall not exceed the sum of TEN THOUSAND DOLLARS (\$10,000). All required documents were sent for review through the Economic Development Department and the solicitation is compliant with the Webb County Single Point of Contact (SPOC) procedures. Issue: Submission of Assistance to Firefighters Grant (AFG) Application to benefit the Webb County Volunteer Fire Department through the acquisition of personal protective equipment for firefighters, hoses for fire trucks, and a removable skid unit for a military vehicle.

Solution: The Economic Development Department will develop and submit the application on behalf of the Webb County Volunteer Fire Department.

Result: Well- equipped firefighters to respond safely to emergency incidents, and meet required standards.

15. Head Start

- a. Discussion and possible action to enter into a Six (6) month Professional Services Agreement (February 1, 2021 through August 31, 2021) between Webb County on behalf of Webb County Head Start/Early Head Start Program ("Head Start") and PILLAR to provide Trauma-Based Treatment training and services for Head Start employees, parents and/or clients at an hourly rate of Four Hundred Dollars (\$400.00) and authorizing the County Judge to execute all relevant documents; and any other matters incident thereto. Result: The golf course will have enough carts to facilitate the growth and demand of increased rounds of golf at Casa Blanca and to better serve our community with larger tournament quantities.


