Asbestos Survey

A survey of the subject area referenced above will be conducted to determine the presence or absence of ACBM in materials scheduled for disturbance. Suspect materials will be bulk sampled from the subject area and analyzed for possible asbestos content. The samples will be collected by a TDSHS licensed Asbestos Inspector. The bulk samples will be collected using sampling protocols as outlined in the Texas Asbestos Health Protection Rules (TAHPR). The samples will be analyzed by a TDSHS-licensed laboratory using Polarized Light Microscopy (PLM) Methods.
