Introduction

The Texas Legislature appropriated funds to support programs that provide prosecution resources for District and County Attorneys along the Texas-Mexico border and for counties that are significantly affected by border crime.

Project Summary:

Briefly summarize the project, including proposed activities and intended impact.

Pursuant to Texas Government Code 772.0071, the Border Prosecution Unit (hereinafter referred to as BPU) of the 49th Judicial District, covers Webb County and Zapata County, Texas, which is part of the border region since it is adjacent to the international border between the United State of America and Mexico. The eligible prosecuting attorneys of the BPU are attorneys who represent the state in the prosecution of felonies. There are currently three eligible prosecuting attorneys assigned to the BPU. The border crimes prosecuted by the BPU involve transnational criminal activity that undermines public safety or security, such as Homicides, Kidnappings, Smuggling of Persons, Trafficking of Persons, Aggravated Assault with a Deadly Weapon, Engaging in Organized Criminal Activity, drug offenses, and others. However, the majority of the cases that are received by the BPU involve Smuggling of Persons. One of the BPU prosecutors is the Regional Counsel for Region 2. He offices out of the Texas Department of Public Safety (hereinafter referred to as DPS) Criminal Investigations Division (hereinafter referred to as CID) in Laredo, Texas. The strategic placement of the Regional Counsel in the DPS local office not only allows direct and immediate access by CID investigators to the BPU, but also to any DPS trooper housed in that location, in addition to providing access in a known and common environment to other follow troopers. In addition to the three prosecutors, there is also a legal assistant and an investigator assigned full-time to the BPU. The BPU investigator is tasked with assisting in active cases with BPU prosecutors and ongoing investigations. Besides working with state law enforcement, the BPU also works closely with other local law enforcement agencies by providing guidance, and assisting with search and arrest warrants. Due to COVID-19 limitations, the BPU prosecutors have attended training in person and virtually in a variety of relevant legal topics such as the federal and Texas exclusionary rule, human smuggling, deadly conduct investigations, and report writing. In addition, pursuant to Title 37, Chapters 221-225 of the Texas Administrative Code, BPU also provides training for law enforcement officers that follow the Texas Commission on Law Enforcement (TCOLE). The BPU will continue to attend and conduct relevant training as permitted within the COVID-19 limitations. The BPU Region 2, 49th Judicial District, is also a member of the LAREDO UNIFIED COMMAND. The Unified Command is spearheaded by U.S. Border Patrol and includes almost every local, state, and federal law enforcement agency, including the United States Department of State. The Unified Command meets regularly for intelligence briefings and updates on local and area challenges along the U.S.-Mexico border. The BPU is also associated with "specially designed" law enforcement task force groups that include the Texas Department of Public Safety Criminal Investigations Division (DPS CID); the Laredo Police Department; the Department of Homeland Security (DHS), Immigration and Customs Enforcement (ICE), Customs and Border Protection (CBP-Border Patrol), and in some cases the FBI and DEA. One initiative, the Juvenile and Gang Enforcement Team (JAGET) is housed at the Laredo Police Department. Currently, the BPU is working with DPS in Operation Secure Border which was initiated to combat the recent high influx of undocumented individuals crossing the border and the associated border related crimes in BPU Regions 2 and 3. Subsequent to these projects, the BPU will continue working with the United States Attorney's offices in the Western and Southern Districts of Texas whenever any assistance is needed. The Border Prosecution Unit encompasses several communities within two counties. The unit will continue in its mission of investigating and prosecuting cases, some of which have significant ties to criminal organizations along the border while fostering cooperation to reduce threats, improve border security and protect human rights.

Problem Statement:

The drug war raging along the U.S.-Mexico border has fueled violence on both sides causing a devastating impact on the American territories for over a decade. As the cartel violence spillover increases into the nation, the image of the American border communities is unpredictable and extremely unsafe. The border communities of Webb and Zapata counties live on the front line of this drug war and understand the dynamics and the impact it has taken upon this region. This war exists as a result of the endless struggle of the drug cartels competing for control of the drug trade that feeds America's demand for Mexican and South American drugs. These communities are also first-hand witnesses to the battle over the most opportune route for the drug trafficking organizations (DTOs), which is the Interstate Highway 35 corridor. This community has become the nation's largest inland port with warehousing, trade and transportation services as the main economic activities for this rapidly growing city due to the convergence of all land transportation systems (The Texas Border with Mexico: Opportunities and Challenges,

J. M., Patrick, Texas Center for Border Economic and Enterprise Development). With its interstate highway, heavy influx of vehicular and tractor-trailer traffic, and vast amount of warehousing, this busy inland port makes this border region the perfect terminal for drug cartels to smuggle narcotics and undocumented immigrants into the U.S. The ruthless DTO's fighting for control of the region continue to cause the crime rate in northern Mexico to spike while our border region has been gradually confronted with the effects of spillover violence and organized crime. Webb and Zapata counties are not immune and, in fact, have continuously confronted this mayhem. As the cartels wage war across the Rio Grande to capture the lucrative I-35 route, collateral damage is felt on our American side of the border. The level of brutality accompanied with drug production, transportation and distribution of drugs has no respect of this national boundary. The crimes created for our community are an increase in theft, home invasions, kidnappings, attempted kidnappings, attempted murders and murders that are directly related to the activities of the DTO's. They engage in terroristic strategies to expand their criminal operations throughout Texas and the U.S. by working closely with transnational and Texas-based gangs. Criminal street gangs traffic narcotics, smuggle illegal immigrants and transport weapons as well as the proceeds from sales of drugs. The problem is exacerbated because DTO crimes are planned and executed in a more sophisticated, tactical and elaborate manner in the recent years. Even though the Mexican drug war is not within our jurisdiction, our region must deal with the spillover and aftermath. Three local street and prison gangs most involved within our jurisdiction are: the Texas Mexican Mafia, the Texas Syndicate, and the Hermanos Pistoleros Latinos (HPL). According to the last Texas Gang Threat Assessment published in 2018, members of the Texas Mexican Mafia are arrested for more violent crimes than any other gangs (Texas Department of Public Safety, 2018). Across the border in Nuevo Laredo, an area controlled by Cartel De Noreste (CDN), which splintered from Los Zetas, has been warring with its remnants since 2014 in Tamaulipas. As a consequence, CDN's efforts in continually expanding their control of all criminal activities and fending off their rival competition, has resulted in a level of violence that spills into our Laredo community. In addition to cartel activity, local gangs on both sides of the border provide a "work force" for the cartels. Operating either in our community and/or in Nuevo Laredo are gangs such as the Mexican Mafia, Siete Viejo, Tango Blast, Tango Laredo, HPL, among others. These gangs have traditionally generated revenue through the sales of narcotics coming in from Mexico; however, these groups will contract with drug cartels, like "Los Zetas" (CDN), and their rivals, to carry out abductions, retaliatory murders, and other gang related activity. Mexican cartels have become multi-billion-dollar international crime syndicates that dominate the U.S. drug and human smuggling activities (DPS, Border Security Dashboard, January 7, 2015). The problem is identified and established by all local, state, and federal law enforcement agencies and are all committed to fighting against these criminal elements. There is however, a great need for coordination among the agencies and with the prosecutor's office, as well as a need for extensive training in order to best identify practices to disrupt and dismantle criminal enterprises in the U.S. The Smuggling of Persons cases are often committed by local criminal organizations from both side of the border, including Mexican cartels. Existing Capability Levels:

The BPU's existing capability levels are only made possible through funding granted by the Homeland Security Grants Division of the Texas Governor's Office. Consequently, the BPU is fully staffed with 100% grant funded full time employees; three prosecutors, one investigator, and one paralegal. All of the BPU staff is housed at the Webb-Zapata County District Attorney's Office except for the Regional Counsel, who is stationed at the local DPS office for streamlined assistance to DPS personnel. This Border Prosecution Project enhances and builds upon the current capabilities of the 49th Judicial District Attorney's Office, which serves Webb and Zapata Counties. The 49th Judicial District Attorney's Office also consists of 28 Prosecutors, 23 Criminal Investigators, and 32 support staff who work alongside the BP Unit. The DA's office has the current capability of case management software, which the BPU uses to improve the quality of case management workflow for prosecution. The BPU prosecutors are assigned individual laptops to work from home as needed and to use for presentations. BPU recently received external DVD drives and an external hard drive to assist with reviewing and obtaining evidence from law enforcement. The Regional Counsel also has an issued cell phone for 24-hour contact availability. In addition, the other two BPU prosecutors have agreed to be available days and evenings as well.

Capability Gaps:

One of the issues that the BPU has recognized is how some federal agents along the local border area are limited by constantly-changing local policies and federal law regarding the prosecution of smuggling of persons cases. Such limitations can range from the number of undocumented immigrants detained after a smuggler is arrested to the age of the smuggler or of the immigrants. The BPU may be able to assist in this type of cases since the same federal policy and legal limitations do not necessarily apply to our office or the State. Another capability gap that is addressed by the BPU is the ability to collaborate closely with local law enforcement in the investigation and

prosecution of criminals. Since the State and local agencies are not limited by the same restrictions to information sharing as the federal government and federal agencies, the BPU, State, and local enforcement are able to work more efficiently with each other, without delay due to strict policies. In addition, the BPU is even able to assist federal prosecutors with information on common defendants for federal prosecution purposes.

Impact Statement:

The goal of the Border Prosecution Unit is to accurately identify and proactively address emerging threats enhancing long-term investigations of criminal organizations that threaten the security of the communities along the U.S.-Mexico border. Border prosecutors in the region continue to be involved in serving and assisting law enforcement in significant border and transnational crimes. Prosecutors will facilitate the flow of information between agencies at the local, state, and, when possible, federal levels and will be available 24 hours a day to assist law enforcement officers in the investigation and development of cases. Moreover, the BPU will continue its role in managing and supervising investigations and prosecutions of border related crime. BPU will also continue to provide "in house" service to the Texas Department of Public Safety Criminal Investigations Division, DPS State Troopers, assist local law enforcement agencies, and increase participation with our federal counterparts. The BPU has and will develop trainings to provide opportunities for all law enforcement agencies to further understand what is required by the state judicial system versus the federal judicial system. Lastly, the border prosecutors will also act as a liaison in coordinating law enforcement inquiries and requests for assistance in investigations and prosecutions across all jurisdictions regardless of geographical boundaries.

While the proposed project benefits the nation as a whole, the south Texas region in which the counties of Webb and Zapata are located will benefit directly. Those expected to benefit from this project include over 292,000 residents of the 49th Judicial District that reside in Webb and Zapata Counties. These residents will benefit directly, as the border crimes that occur within the jurisdiction will be thoroughly investigated and prosecuted, making for a safer community. BPU funds, however, will undoubtedly serve the entire nation, which continues to be affected by border crime.
