# Lopez Early College High School – Roof Replacement (Phase 1)

BROWNSVILLE, TEXAS | BROWNSVILLE ISD

Raba Kistner's RGV-Building Envelope Team has a long history of working with Brownsville ISD's Facilities Department. Before Raba Kistner was selected for this project, BISD was concerned that the Project Timeline was too tight to achieve Substantial Completion by December 31, 2020. In addition to this challenge, only \$2.823 Million was available for the Project.

Raba Kistner received a design contract on June 11, 2020. In less than three weeks, Construction Documents were issued. The design included time and cost saving features and was defined with alternates to provide BISD with the greatest flexibility to utilize the available funds. On August 7, 2020, Brownsville ISD signed a contract for construction to reroof all areas all areas, including all alternates, for over over a half a Million dollars less than the funds budgeted (no value engineering was needed during Bidding & Negotiation). Substantial Completion of the Project was reached on December 9, 2020 (22 days ahead of schedule) at a final cost of \$2,274,000 (\$549,000 under budget.)

- **Exterior Wall Restoration**
- Replacement of 51 skylight units
- Mechanical, Electrical & Plumbing Repairs
- Reuse of portions of existing roof system (to save on insulation cost)

# Assessment of Structure and Roofing Systems at the Old Lacks Store

MISSION, TEXAS | MISSION CISD




