WEBB COUNTY COMMISSIONERS COURT

**REESTABLISHING AND REDEFINING COUNTY
ELECTION PRECINCTS**

WHEREAS, the county election precinct (aka, VTD or voting tabulation district) is the basic electoral unit to conduct elections; and

WHEREAS, a county commissioners court is responsible for the establishment of county election precincts within its jurisdiction in accordance with the provisions of Chapter 42 of the Texas Election Code which govern the composition of county election precincts; and

WHEREAS, pursuant to Section 42.005 of the Texas Election Code, a county election precinct may not contain territory from more than one commissioner precinct, justice precinct, congressional district, state representative district, state senatorial district, or State Board of Education district; and

WHEREAS, Section 42.006 of the Texas Election Code provides that each county election precinct in Webb County contain at least 100 but no more than 5,000 registered voters unless its application results in a conflict with Section 42.005 of the Texas Election Code in which the provisions of Section 42.005 prevail [see §42.005(b)]; and

WHEREAS, pursuant to Section 42.007 of the Texas Election Code, a county election precinct may not contain territory inside a municipality of a population of 10,000 or more together with unincorporated of the county unless the commissioners court determines that it cannot constitute a separate election precinct of suitable size or shape containing the permissible number of voters or it causes another election precinct to fail to meet those requirements; and

WHEREAS, the Webb County Commissioners Court must reestablish, redefine and renumerate county election precincts as necessary to conform to the effects of 2021 redistricting plans, changes in local political boundaries and to contain, to the extent possible, the appropriate number of registered voters in compliance with provisions of Chapter 42 of the Texas Election Code; and

WHEREAS, on this 13th day of December 2021, the Webb County Commissioners Court met in a REGULAR meeting to discuss and consider the reestablishment and redefining of election precincts, as submitted and recommended by staff, in accordance with provisions of Chapter 42 of the Texas Election Code.

NOW THEREFORE, IT IS HEREBY ORDERED by the Webb County Commissioners Court, with all members of the Court being present and voting affirmatively, that Webb County, a political subdivision of the State of Texas, be and hereby is REESTABLISHED, REDEFINED, and RENUMERATED into the respective election precincts hereinafter described and enumerated and hereby created, established and redefined as set forth:

Section 1: The Webb County Election Precincts hereinafter set forth are hereby created, established, defined and described by natural or artificial boundaries or survey lines as more particularly described in **Exhibit A**, which is attached hereto and incorporated herein by reference as if copied verbatim.

Section 2: The Court finds that no election precinct herein established has resident therein of more than 5,000 registered voters as ascertained by the current certified lists of qualified voters; however, **Election Precincts numbered 278 and 457** contain less than 100 registered voters. In accordance with the provisions of the Section 42.005(b) of the Texas Election Code, the Court here now finds that **Election Precincts numbered 278 and 457** shall remain as established herein because neither election precinct can be formed into, or be included within, an election precinct containing a suitable number of registered voters that does not contain territory from more than one commissioner precinct, justice precinct, or state representative district.

Section 3: The Court further finds that **Election Precincts numbered 154, 176, 250, 255, 274, 349, 447, 448, and 457** include territory within the corporate limits of the City of Laredo and also adjacent land in unincorporated territory. In accordance with the provisions of Section 42.007 of the Texas Election Code, the Court here now finds that the unincorporated territory adjacent to that territory within the corporate limits of the City of Laredo is so situated that it cannot be formed into, or be included within, an election precinct wholly outside the City of Laredo of suitable size and shape and containing a suitable number of registered voters or without causing a conflict with Section 42.005 of the Texas Election Code.

Section 4: In the event there is a discrepancy between the boundary lines as set forth on the maps filed with the Webb County Elections Administrator's Office or the Webb County Clerk's Office and the boundaries of the written descriptions as set forth herein in **Exhibit A**, the written descriptions as attached hereto shall prevail.

Section 5: The creation, establishment, and redefining of the Election Precincts of Webb County shall become effective from and after the **1st day of January 2022**, and not prior thereto and that the Election Precincts heretofore established and existing as of the date of this Order of this Court shall continue and remain in status quo and in full force and effect during the remainder of the calendar year 2021.

Section 6: The Clerk of this Court shall immediately cause to be published on the County's official website and in a newspaper of general circulation published in Webb County, Texas, once each week for three consecutive weeks a notice of the entry of this Order giving a brief description in general terms of the changes made or a true copy of this order itself.

Section 7: The Clerk of this Court shall cause certified copies of this Order to be delivered to the Office of the Secretary of State pursuant to the provisions the Texas Election Code; to incumbent County Commissioners of Webb County, Texas, to the Webb County Elections Administrator and other entities and individuals as may be required by law.

ELECTION PRECINCT NO. 123

Election Precinct No. 123 shall consist of all that territory described as follows:

BEGINNING at a point in the City of Laredo where the International Border at the Rio Grande and an extension of the Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) intersects the centerline of Chacon Creek for the southeast corner and POINT-OF-BEGINNING of this tract;

THENCE, in a northeasterly direction along the centerline of Chacon Creek, and its meanders, to a point where the centerline of Chacon Creek intersects the centerline of Meadow Avenue same being an extension of said Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) for the southeast corner of this tract;

THENCE, in a northerly direction along the centerline of Meadow Avenue same being the common boundary of said Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) to a point where the centerline of Meadow Avenue intersects the centerline of Market Street for the northeast corner of this tract;

THENCE, in a westerly direction along the centerline of Market Street same being an extension of said Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) to a point where the centerline of Market Street intersects the centerline of Zacate Creek for the northwest corner of this tract;

THENCE in a southeasterly and southwesterly direction along the centerline of Zacate Creek, and its meanders, to a point where the centerline of Zacate Creek intersects the International Border at the Rio Grande and re-intersects an extension of said Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) for the southwest corner of this tract;

THENCE, in a southeasterly direction along the International Border at the Rio Grande same being the common boundary of said Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316), and its meanders, to the POINT-OF-BEGINNING.

ELECTION PRECINCT NO. 124

Election Precinct No. 124 shall consist of all that territory described as follows:

BEGINNING at a point in the City of Laredo where the centerline of Market Street intersects the centerline of Meadow Avenue for the northwest corner and POINT-OF-BEGINNING of this tract;

THENCE, in an easterly direction along the centerline of Market Street to a point where the centerline of Market Street intersects the centerline of Ejido Avenue for the northeast corner of this tract;

THENCE, in a southeasterly direction along the centerline of Ejido Avenue to a point where the centerline of Ejido Avenue intersects an extension of Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) for the southeast corner of this tract;

THENCE, in a westerly and southerly direction along the meanders of said Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) to a point where said state representative line intersects the centerline of the Meadow Avenue for the southwest corner of this tract;

THENCE, in a northwesterly and northerly direction along the centerline of Meadow Avenue to the POINT-OF-BEGINNING.

ELECTION PRECINCT NO. 125

Election Precinct No. 125 shall consist of all that territory described as follows:

BEGINNING at a point in the City of Laredo where the centerline of Guadalupe Street intersects the centerline of Ejido Avenue for the northwest corner and POINT-OF-BEGINNING of this tract;

THENCE, in a southeasterly direction along the centerline of Ejido Avenue, same being the westerly boundary of Blocks 1008, 1013, 1021, 1018, of the US Census Tract 1003, continuing in a southerly direction along Blocks 1004 and 1008 of the US Census Tract 0105, until the westerly boundary of said census blocks re-intersects with the centerline of Ejido Avenue, same being an extension of Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316), to a point where said state representative line and the centerline of Ejido Avenue intersects the centerline of Jaime Zapata Memorial Highway for the southwest corner of this tract;

THENCE, in a northeasterly and northerly direction along the centerline of Jaime Zapata Memorial Highway to a point where the centerline of Jaime Zapata Memorial Highway intersects the centerlines of State Highway 359 (SH 359) and Bob Bullock Loop for the southeast corner of this tract;

THENCE, in a westerly direction along the centerline of SH 359 to a point where the centerline of SH 359 intersects the centerline of Dorel Drive for an interior corner and point of deflection of this tract;

THENCE, in a northerly direction along the centerline of Dorel Drive to a point where the centerline of Dorel Drive intersects the centerline of Daniela Loop for a point of deflection of this tract;

THENCE, in an easterly, northerly, and westerly direction along the centerline of Daniela Loop, and its meanders, to a point where the centerline of Daniela Loop re-intersects with the centerline of Dorel Drive for a point of deflection of this tract;

THENCE, in a northerly direction along the centerline of Dorel Drive to a point where the centerline of Dorel Drive intersects the northern boundary of Loma Alta Subdivision as recorded in Volume 3, Page 11 of the Webb County Plat Records for an exterior corner and

point of deflection of this tract;

THENCE, in a westerly direction along the northern boundary of said Loma Alta Subdivision until the northern boundary of Loma Alta Subdivision intersects the centerline of Chacon Creek for an interior corner of this tract;

THENCE, in a northerly and northeasterly direction along the centerline of Chacon Creek, and its meanders, to a point where the centerline of Chacon Creek intersects with Guadalupe Street for the northeast corner of this tract;

THENCE, in a westerly direction along the centerline of Guadalupe Street to the POINT-OF-BEGINNING.

ELECTION PRECINCT NO. 128

Election Precinct No. 128 shall consist of all that territory described as follows:

BEGINNING at a point in the City of Laredo where the International Border at the Rio Grande, same being a common boundary the Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) intersects the centerline of Chacon Creek for the northwest corner and POINT-OF-BEGINNING of this tract;

THENCE, in a northeasterly direction along the centerline of Chacon Creek, and its meanders, to a point where the centerline of Chacon Creek intersects the centerline of Meadow Avenue same being an extension of said Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) for a deflection point of this tract;

THENCE, in a northeasterly direction along said Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316), and its meanders, to a point where said state representative line intersects the centerline of US Highway 83 (US 83) for the northeast corner of this tract;

THENCE, in a southerly and southwesterly direction along the centerline of US 83 to a point where the centerline of US 83 intersects with the centerline of Masterson Road for the southeast corner of this tract;

THENCE, in a westerly direction along the centerline of Masterson Road, same being the northern boundary of the Riverside Subdivision Plat, as recorded in Volume 2, Page 208, Webb County Plat Records to a point where the northern boundary of said Riverside Subdivision Plat intersects with the International Border at the Rio Grande same being an extension of said Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) for the southwest corner of this tract;

THENCE, in northeasterly and northwesterly direction along said International Border at the Rio Grande same being an extension of said Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316), and its meanders, to the POINT-OF-BEGINNING.

ELECTION PRECINCT NO. 129

Election Precinct No. 129 shall consist of all that territory described as follows:

BEGINNING at a point in the City of Laredo where the centerline of US Highway 83 (US 83) intersects an extension of Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) boundary for the northwest corner and POINT-OF-BEGINNING of this tract;

THENCE, in an easterly direction along the boundary, and its meanders, of said Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316), to a point where said state representative line intersects with the centerline of Ejido Avenue for the northeast corner of this tract;

THENCE, in a southerly direction along the centerline of Ejido Avenue to a point where the centerline of Ejido Avenue intersects with the centerline of Pine Street for the southeast corner of this tract;

THENCE, in a westerly direction along the centerline of Pine Street to a point where the centerline of Pine Street intersects with the centerline of US 83, for the southwest corner of this tract;

THENCE in a northeasterly direction along the centerline of US 83 to the POINT-OF-BEGINNING.

ELECTION PRECINCT NO. 130

Election Precinct No. 130 shall consist of all that territory described as follows:

BEGINNING at a point in the City of Laredo where the centerline of Pine Street intersects with the centerline of US Highway 83 (US 83) for the northwest corner and POINT-OF-BEGINNING of this tract;

THENCE, in a southwesterly and southerly direction along the centerline of US 83 to a point where the centerline of US 83 intersects with the centerline of Ireland Street for the southwest corner of this tract;

THENCE, in a predominantly easterly and northeasterly direction along the centerline of Ireland Street until said centerline connects to the centerline of Frio Plaza Court, continuing in an easterly direction until said centerline connects to the centerline of San Jacinto Court, traversing the easterly boundary of Southgate Subdivision Unit II-A Phase II as recorded in Volume 17, Page 59, Webb County Plat Records, to a point along the centerline of Ejido Avenue same being an extension of the Webb County Drainage District No. 1, as recorded in Volume 375, Pages 327-348, for the southeast corner of this tract;

THENCE, in a northerly direction along the centerline of Ejido Avenue and an extension of said Webb County Drainage District No.1, until said centerline of Ejido Avenue connects with an extension of Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) to a point where said centerline of Ejido Avenue and state representative line intersects with the centerline of Pine Street for the northeast corner of this tract;

THENCE, in an easterly direction along the centerline of Pine Street to the POINT-

OF-BEGINNING.

ELECTION PRECINCT NO. 132

Election Precinct No. 132 shall consist of all that territory described as follows:

BEGINNING at a point in the City of Laredo where the international border along the Rio Grande and an extension of the Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) intersects the northern boundary of the Riverside Subdivision Plat, as recorded in Volume 2, Page 208, Webb County Plat Records, for the northwest corner and POINT-OF-BEGINNING of this tract;

THENCE, in an easterly direction along the northern boundary of said Riverside Subdivision Plat until the northern boundary of said plat connects to the centerline of Masterson Road, to a point where the centerline of Masterson Road and northern boundary of said Riverside Subdivision Plat intersects with US Highway 83 (US 83) for the northeast corner of this tract;

THENCE, in a southeasterly and southwesterly direction along the centerline of US 83 to a point where the centerline of US 83 intersects the southern boundary of Porcion 46 same being the north boundary of the City of Rio Bravo corporate limits for the southeast corner of this tract;

THENCE, in a westerly direction along the southern boundary of said Porcion 46 same being the boundary of said City of Rio Bravo corporate limits to a point where the southern boundary of Porcion 46 and said corporate limits intersects the international border along the Rio Grande same being an extension of said Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) for the southwest corner of this tract;

THENCE, in a prevailing northerly direction along the meanders of the International Border along the Rio Grande same being an extension of said Districts 42 and 80 of the Texas House of Representatives as established in H.B. 1, 87th Legislature, 3rd Called Session (Plan H22316) to the POINT-OF-BEGINNING.

ELECTION PRECINCT NO. 133

Election Precinct No. 133 shall consist of all that territory described as follows:

BEGINNING at a point in the City of Laredo where the centerline of US Highway 83 (US 83) intersects the centerline of La Pita-Mangana Road for the northwest corner and POINT-OF-BEGINNING of this tract;

THENCE, in an easterly direction along centerline of La Pita-Mangana Road to a point where said the centerline of La Pita-Magana Road intersects the centerline of San Rafael Lane for the northeast corner of this tract;

THENCE, in a southerly and southwesterly direction along the centerline of San Rafael Lane to a point where the centerline of San Rafael Lane intersects the centerline of Sierra Vista Boulevard for the southeast corner of this tract;

THENCE, in an westerly, northwesterly, and westerly direction along the centerline of Sierra Vista Boulevard, to a point where the centerline of Sierra Vista Boulevard intersects the centerline of US 83 for the southwest corner of this tract;

THENCE, in a northerly direction along the centerline of US 83 to the POINT-OF-BEGINNING.

ELECTION PRECINCT NO. 134

Election Precinct No. 134 shall consist of all that territory described as follows:

Election Precinct No. 0134 shall consist of all that territory located within the corporate limits of the City of Rio Bravo, Texas as said corporate limits existed on January 1, 2001.

BEGINNING at a point in the City of Rio Bravo where the centerline of US Highway 83 (US 83) intersects the south boundary of Porcion 46 same being the north boundary of the City of Rio Bravo corporate limits for the northeast corner and POINT-OF-BEGINNING of this tract;

THENCE, in a southeasterly direction along the east boundary of said City of Rio Bravo corporate limits same being the centerline of US 83 to a point where said corporate limit and the centerline of US 83 intersects with the centerline of Espejo-Molina Road same being the south boundary of said City of Rio Bravo corporate limits for the southeast corner of this tract;

THENCE, in a westerly direction along the centerline of Espejo-Molina Road same being the south boundary of said City of Rio Bravo corporate limits to a point where said corporate limit and the centerline of Espejo-Molina Road intersects with the centerline of Jacobita Road for a point of deflection of this tract;

THENCE, in a northerly and westerly direction along the centerline of Jacobita Road and continuing along the south boundary of said City of Rio Bravo corporate limits to a point where said corporate limit and the centerline of Jacobita Road intersects with the international border along the Rio Grande and the west boundary of said City of Rio Bravo corporate limits for the southwest corner of this tract;

THENCE, in a northeasterly direction along the international border along the Rio Grande and west boundary of said Rio Bravo corporate limits to a point where said international border and said corporate limit intersects with the south boundary of Porcion 46 and north boundary of said City of Rio Bravo corporate limits for the northwest corner of this tract;

THENCE, in an easterly direction along the south boundary of said Porcion 46 and north boundary of said City of Rio Bravo corporate limits to the POINT-OF-BEGINNING.

ELECTION PRECINCT NO. 135

Election Precinct No. 135 shall consist of all that territory described as follows:

Election Precinct No. 0135 shall consist of all that territory located within the corporate limits of the City of El Cenizo, Texas as said corporate limits existed on January 1, 2021.

ELECTION PRECINCT NO. 136

Election Precinct No. 136 shall consist of all that territory described as follows:

BEGINNING at a point along the north right-of-way line State Highway 359 (SH 359) intersects with Kansas City Sothern’s railroad tract (formerly known as the Tex-Mex railroad) for the northwest corner and POINT-OF-BEGINNING of this tract;

THENCE, in a southeasterly and northeasterly direction along the centerline of SH 359 to a point where the north right-of-way line of SH 359 intersects the centerline of Farm-to-Market 649 (FM 649) for a point of deflection of this tract;

THENCE, in a southerly direction along the centerline of FM 649 to a point where the centerline of FM 649 intersects the centerline of Magnolia Road for an interior corner and point of deflection of this tract;

THENCE, in an easterly direction along the centerline of Magnolia Road continuing past the public portion of said road to the private portion until said road intersects with the centerline of said Kansas City Sothern’s railroad tract for a point of deflection of this tract;

THENCE, in a northerly and predominantly easterly direction along the centerline of said railroad tract, and its meanders, until the centerline of said railroad tract intersects the boundary of the Webb County line same being the westerly boundary of Duval County for the northeast corner of this tract;

THENCE, in a southerly direction along the eastern county line boundary of Webb County same line being the common boundaries with the counties of Duval and Jim Hogg to the southern boundary of Webb County for the southeast corner of this tract;

THENCE, in a westerly direction along the southern boundary of Webb County same being the common boundary with the counties of Jim Hogg and Zapata until the southern boundary of Webb County intersects the centerline of Jennings Road for the southwest corner of this tract;

THENCE, in a northwesterly and northeasterly direction along the centerline of Jennings Road to a point where the centerline of Jennings Road intersects with said Kansas City Sothern’s railroad tract for an interior corner and point of deflection of this tract;

THENCE, in a westerly direction along said Kansas City Sothern’s railroad tract to the POINT-OF-BEGINNING.

ELECTION PRECINCT NO. 154

Election Precinct No. 154 shall consist of all that territory described as follows:

BEGINNING at a point in the City of Laredo where the centerline of US Highway 83 (US 83) intersects the centerline of Sierra Vista Boulevard for the northwest corner and POINT-OF-BEGINNING of this tract;

THENCE, in an easterly, southeasterly, and predominantly easterly direction along the centerline of Sierra Vista Boulevard to a point where the centerline of Sierra Vista Boulevard intersects with the centerline of Cuatro Vientos Road for an interior corner of this

tract;

THENCE, in a northerly direction along the centerline of Cuatro Vientos Road to a point where the centerline of Cuatro Vientos Road intersects with the centerline of Pita-Mangana Road same being an extension of the boundary of Webb County Drainage District No. 1, as recorded in Volume 375, Pages 327-375, Deed Records of Webb County Texas, for a point of deflection of this tract;

THENCE, in an easterly direction along an extension of said Webb County Drainage District No.1 same being the centerline of Pita-Mangana Road continuing past the public portion of said road to the private portion to a point where said centerline of Pita-Mangana Road ends and said drainage district boundary continues in a northerly direction until said drainage district boundary intersects with the centerline of Wormser Road for an exterior corner and point of deflection of this tract;

THENCE, in a southeasterly and predominately easterly direction along the boundary of said Webb County Drainage District No. 1 and the centerline of Wormser Road traversing both the public and private portions of said road to a point where the private portion of the road turns south, same being the northwest corner of Block 1591 of Tract 1813 of the US Census for a point of deflection of this tract;

THENCE, in an easterly, northerly and northeasterly direction along the Census line being the northern boundaries of Blocks 1591, 1592, 1594, 1596, 1111 and the western Census boundaries of blocks 1111 and 1104 of the US Census Tract 1813 to a point where those Census lines intersect the centerline of State Highway 359 (SH 359), same being the northwest corner of Block 1104 of the US Census Tract 1813; this point is located approximately 0.64 miles west of Pescadito Road's intersection with SH 359, for a point of deflection of this tract;

THENCE, in a predominantly easterly direction along the centerline of SH 359 to a point where the centerline of SH 359 intersects Kansas City Sothern's railroad tract (formerly known as the Tex-Mex Railroad) for the northeast corner of this tract,

THENCE, in a southeasterly direction along said Kansas City railroad tract to a point where said railroad tract intersects with the centerline of Jennings Road for a point of deflection of this tract;

THENCE, in a southwesterly and southeasterly direction along the centerline of Jennings Road to a point where Jennings Road intersects with the southern boundary of Webb County same being the common boundary with the counties of Jim Hogg and Zapata for the southeast corner of this tract;

THENCE, in a westerly direction along the southern boundary of Webb County same being the boundary of Jim Hogg County until the southern boundary of Webb County intersects with the International Border along the Rio Grande for the western boundary of Webb County and the southwest corner of this tract;

THENCE, in a prevailing southeasterly, southerly and easterly direction along the meanders of the international boundary at the Rio Grande same being the western boundary of Webb County to a point of said boundary intersects the common boundary line of Districts 80 & 42 of the Texas House of Representatives for a point of deflection of this tract;

THENCE, in a predominantly northeasterly direction along the centerline of the common boundary line of Districts 80 & 42 of the Texas House of Representatives and its meanders to the POINT-OF-BEGINNING.

ELECTION PRECINCT NO. 458

Election Precinct No. 458 shall consist of all that territory described as follows:

BEGINNING at a point in the City of Laredo where the centerline of Interstate Highway 35 (IH 35) intersects the centerline of Bob Bullock Loop for the northeast corner and POINT-OF-BEGINNING of this tract;

THENCE, in a westerly direction along the centerline of Bob Bullock Loop, and its meanders to a point where the centerline of Bob Bullock Loop intersects the international border along the Rio Grande for the northwest corner of this tract;

THENCE, in a southerly direction along the international border along the Rio Grande, and its meanders, to a point where the international border along the Rio Grande intersects the centerline of Rancho Viejo Drive for the southwest corner of this tract;

THENCE, in an easterly direction along the centerline of Rancho Viejo Drive to a point where the centerline of Rancho Viejo Drive intersects the centerline of FM 1472 for an interior corner of this tract;

THENCE, in a southerly direction along the centerline of FM 1472 to a point where the centerline of FM 1472 intersects the centerline of IH 35 for the southeast corner of this tract;

THENCE, in a northerly direction along the centerline of IH 35, and its meanders, to the POINT-OF-BEGINNING.

BEGINNING at a point in the City of Laredo where the centerline of Hillside Road intersects the centerline of Gallagher Avenue for the northeast corner and POINT-OF-BEGINNING of this tract;

THENCE, in a southerly direction along the centerline of Gallagher Avenue to a point where the centerline of Gallagher Avenue intersects the centerline of Calton Road for a point of deflection of this tract;

THENCE, in an easterly direction along the centerline of Calton Road to a point where the centerline of Calton Road intersects the centerline of Mims Avenue for a point of deflection of this tract;

THENCE, in a southerly direction along the centerline of Mims Avenue to a point where the centerline Mims Avenue intersects the centerline of Canal Street for the southeast corner and a point of deflection of this tract;

THENCE, in a westerly direction along the centerline of Canal Street to a point where an extension of the centerline of Canal Street intersects the centerline of Interstate Highway 35 (IH 35) for the southwest corner and a point of deflection for this tract;

THENCE, in a northerly direction along the centerline of IH 35 to a point where the centerline of IH 35 intersects the centerline of Hillside Road for the northwest corner and a point of deflection for this tract;

THENCE, in an easterly direction along the centerline of Hillside Road to the POINT-OF-BEGINNING.

ELECTION PRECINCT NO. 462

Election Precinct No. 462 shall consist of all that territory described as follows:

BEGINNING at a point in the City of Laredo where the centerline of Interstate Highway 35 (IH 35) intersects the centerline of Frankfort Street for the southwest corner and POINT-OF-BEGINNING of this tract;

THENCE, in an easterly direction along the centerline of Frankfort Street to a point where the centerline of Frankfort Street intersects the centerline of Zacate Creek for the southeast corner of this tract;

THENCE, in a northerly direction along the centerline of Zacate Creek to a point where the centerline of Zacate Creek intersects the centerline of the Canal Drainage channel for the northeast point of this tract;

THENCE, in a westerly direction along the centerline of the Canal Drainage channel to a point where the centerline of the Canal Drainage channel intersects the centerline of IH 35 for the northwest corner of this tract;

THENCE, in a northerly direction along the centerline of IH 35 to a point where the centerline of IH 35 intersects the northern boundary of Abstract 239, Survey 799 for the northeast corner of this tract;

THENCE, in a predominantly westerly direction along the northern boundary of Abstract 239, Survey 799 to a point where the northern boundary of Abstract 239, Survey 799 intersects the centerline of Markley Lane and continuing in along in a westerly direction until said centerline intersects the centerline of Los Martinez Drive for the northwest corner of this tract;

THENCE, in a southwesterly direction along the centerline of Los Martinez Drive to a point where the centerline Los Martinez Drive intersects the centerline of Sergio Street for the southwest corner and a point of deflection of this tract;

THENCE, in a southeasterly direction along the centerline of Sergio Street to a point where the centerline of Sergio Street intersects the centerline of Riverside Drive for an interior corner and point of deflection for this tract;

THENCE, in a southwesterly direction along the centerline of Riverside Drive to a point where the centerline of Riverside Drive intersects the centerline of Geronimo Drive for an exterior corner and point of deflection for this tract;

THENCE, in an easterly direction along the centerline of Geronimo Drive to a point where the centerline of Geronimo Drive intersects the centerline of Rio Grande Drive for an exterior corner and point of deflection for this tract;

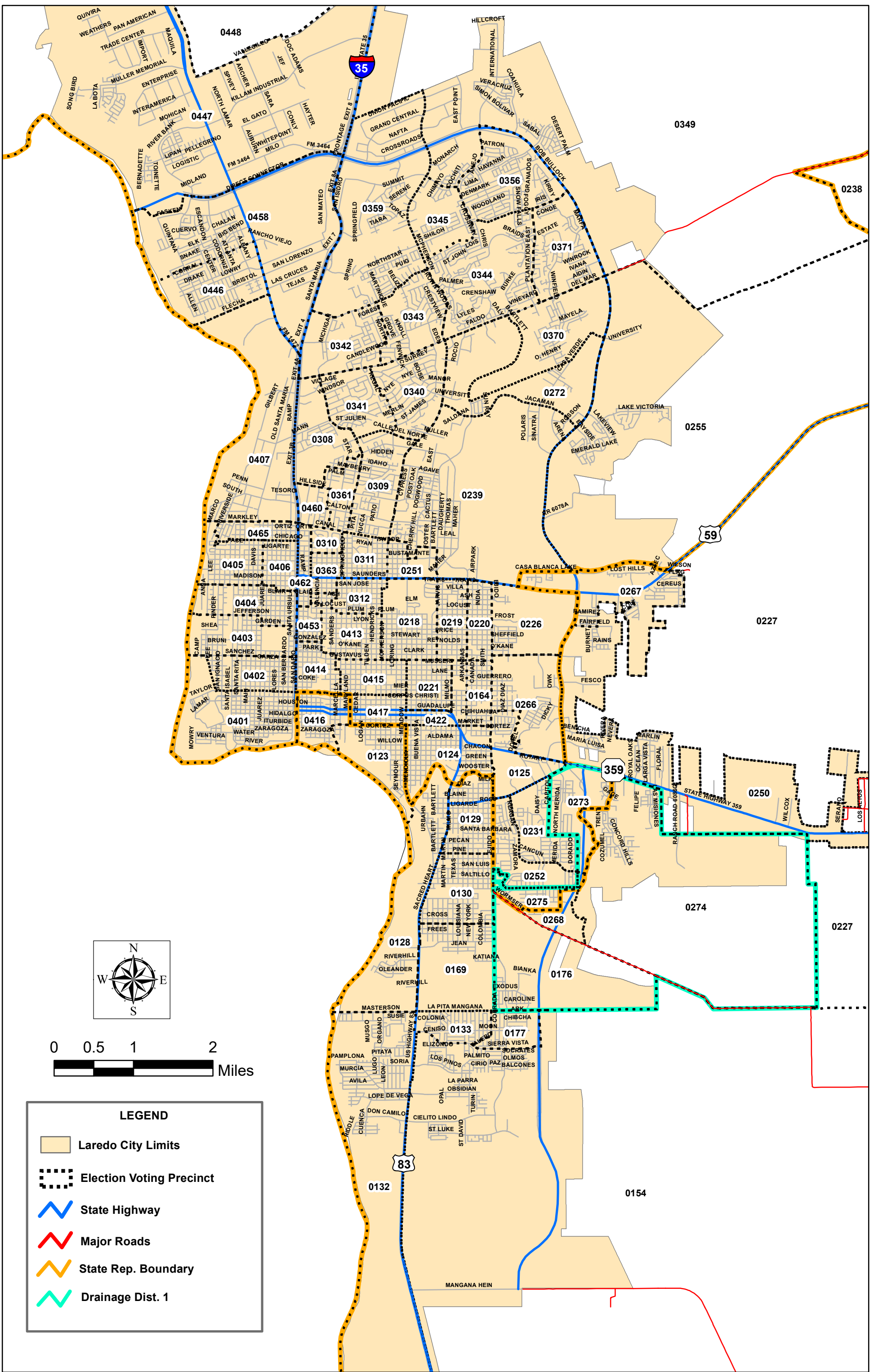

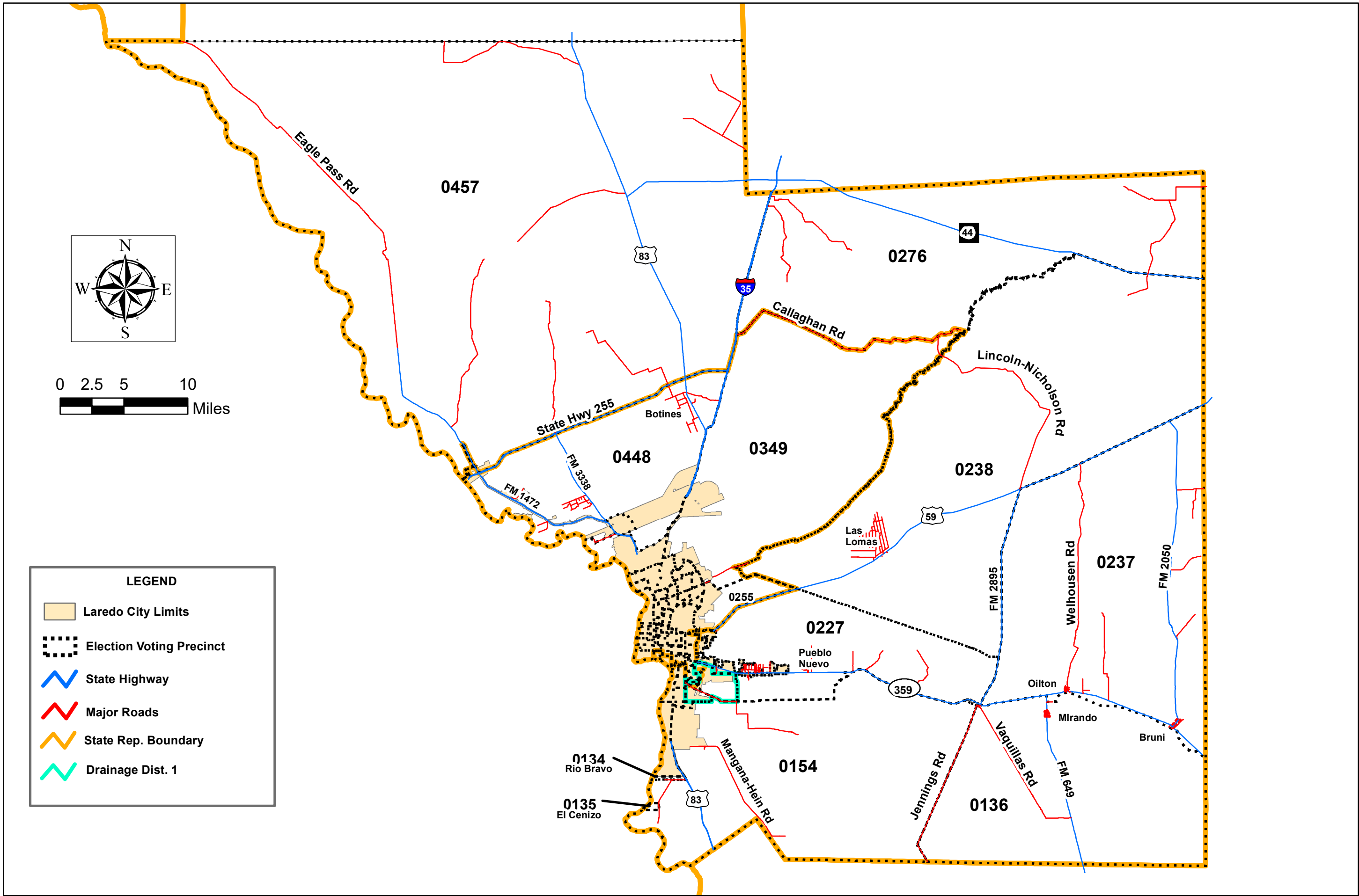
