#### Representative Experience

#### **Transportation**

Winstead attorneys have represented local governments and engineering and general contractor clients in transportations disputes regarding payment, delay and design and construction defect matters.

Representative examples of those matters include:

- Winstead represented Hays County, Texas in a dispute with SEMA Construction, Inc. ("SEMA") regarding the construction of the north end of FM 1826. SEMA alleged that the county failed to timely relocate utilities along the proposed route causing cost overruns and delays to the completion of the project. Hays County countered that the project was not delivered timely. Hays County sought to withhold payment from the final contract payment and SEMA sought in excess of \$4 million. The matter was resolved prior to trial. SEMA Construction, Inc. v. Hays County, Texas, Case No. 16-2563, In the District Court of Hays County, Texas, 274th Judicial District.
- Winstead represented HNTB Corporation in a dispute brought by the North Texas Tollway Authority regarding the design and construction of various mechanically stabilized earth walls

along various sections of the NTTA turnpike system. HNTB was the general engineering consultant of the NTTA. The NTTA sought in excess of \$100 million from a variety of engineering and general contractor defendants. The matter was resolved prior to trial. *North Texas Tollway Authority v. Zachary Construction Corporation, n/k/a Zachry Industrial, Inc.; et al.*, Case No. 429-01326-2017; In the District Court of Collin County, Texas, 429th Judicial District.

- Winstead represents Hays County, Texas in a dispute with Texas Sterling Construction regarding the construction of the southern portion of FM 1626. Texas Sterling contends that the project was delivered late as a result of issues not caused by Texas Sterling. Hays County seeks to withhold payment from the final contract payment and Texas Sterling seeks in excess of \$6 million. The matter is currently scheduled for mediation.
- Winstead represented Williams Brothers Construction Company, Inc. ("Williams Brothers") in Cause No. 2014-59386, J.A. Manning Construction Inc. v. Williams Brothers Construction Company, Inc. et al., In 334th Judicial District of Harris, County Texas ("J.A. Manning Lawsuit"). The J.A. Manning Lawsuit centered around two public highway construction projects in which Williams Brothers served as the prime contractor and J.A. Manning Construction Inc. ("J.A. Manning") served as Williams Brothers' subcontractor. Specifically, the two projects were: (1) the State Highway 121/Southwest Parkway, Section 1 Project (Contract No. 02076-SWP-01-CN-PM) owned by North Texas Tollway Authority ("NTTA") in Tarrant County Texas (the "NTTA Project"); and (2) the construction project on US 281 North/Loop 1604 Interchange in Bexar County, Texas for Alamo RMA (the "ARMA Project"), Williams Brothers and J.A. Manning entered into Subcontract No. 469.04 that required J.A. Manning to provide material and labor on the NTTA Project (the "NTTA Subcontract") and similarly entered into Subcontract No. 466DB-19 for the ARMA Project (the "ARMA Subcontract"). During the course of the NTTA Project, J.A. Manning did not timely perform its scope of work, performed defective work rejected by NTTA that required correction, failed to pay its suppliers, and did not comply with numerous other contractual obligations. Consequently, and after issuing a number of notices to J.A. Manning regarding these matters in which it failed to remedy these defaults or provide reasonable assurance of future compliance as required by the NTTA Subcontract, Williams Brothers terminated the NTTA Subcontract, Following termination of the NTTA Subcontract, J.A. Manning initiated the J.A. Manning Lawsuit asserting claims against Williams Brothers for wrongful termination, tortious interference of a prospective business relationship, quantum meruit, unjust enrichment, breach of contract, and exemplary damages in connection with the NTTA Project. In addition, J.A. Manning asserted limited claims on the ARMA Project for alleged extra work under the ARMA Subcontract. Winstead successfully defended Williams Brothers against J.A. Manning's claims in the J.A. Manning and obtained a summary judgment in Williams Brothers' favor that ultimately resulted in the ended of the J.A. Manning Lawsuit.
- Winstead represented URS Corporation n/k/a AECOM in a suit filed by three landowner plaintiffs regarding the design and construction of the US 183A tollway. Plaintiffs sued multiple design and construction defendants and claimed that the design and construction of the tollway increased flooding on their property. The matter was resolved prior to trial. First Baptist Church et al. v. HNTB; Case No. D-1-GN-09-002038; In the District Court of Travis County, Texas, 98th Judicial District.

#### **Higher Education**

Winstead's Construction Practice Group currently represents or has been approved to represent all 7 public higher education systems in Texas, as well as many private higher educational institutions such as Texas Christian University and Southern Methodist University with regard to student housing, classroom and other infrastructure development, and sports venues.
