



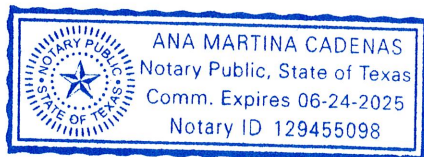

**CERTIFICATION REGARDING FEDERAL LOBBYING**
