RE: Response to Request for Qualifications (RFQ 2023-011) – Professional Consultation Services for the Development of Special Districts in Webb County

To Whom It May Concern:

As someone with deep roots to Laredo, I am sincerely excited for the opportunity to provide this response to the Webb County (the *County*) Request for Qualifications (*RFQ*) referenced above. My team understands that a successful special district transaction involves the coordination of several professionals, and the County's engagement of several consultants. By submitting this response, we hope to demonstrate that our attorneys at McCall, Parkhurst & Horton L.L.P. (*McCall* or the *Firm*) are ideally suited to serve as legal consultants to the County in relation to the potential creation of special districts within the County, and potential issuances of debt in relation thereto. Our team is not only able and willing to serve as a member of the County's team, we are eager to do so. Throughout the course of our Firm's history, McCall has represented, and continues to represent, counties in all aspects of debt and financing transactions. II. EXECUTIVE SUMMARY

Legal Services to Be Provided
