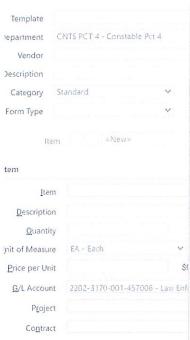
INSTRUCTIONS:

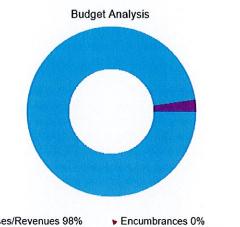
