

**WEBB COUNTY COMMISSIONER'S**  
**COURT ORDER NO. 2023-06/12/2023**

**WHEREAS**, Section 251.016 of the Texas Transportation Code authorizes and states that the Webb County Commissioners Court may exercise general control over all roads, highways, and bridges in Webb County; and

**WHEREAS**, Section 251.051 of the Texas Transportation Code allows the Webb County Commissioners Court to order public roads to be closed, abandoned, altered, or vacated; and

**WHEREAS**, Section 251.052 of the Texas Transportation Code also allows the residents of a County precinct to apply for a change in an existing road by presenting to the Webb County Commissioners a petition requesting such a change to an existing road; and

**WHEREAS**, the City of Laredo has requested and petitioned the Webb County Commissioner's Court to proceed with annexation and incorporation of approximately 1.3 miles and/or 6,850 linear foot wide portion of Wormser Road, currently owned and controlled by Webb County into the city limits of the City of Laredo; and,

**WHEREAS**, Wormser Road is being considered to be temporarily closed and re-aligned and re-routed as shown on Exhibit "A", as a public roadway due to ongoing construction upon issuance of an Order by the Webb County Commissioner's Court after a public hearing and vote on the matter; and,

**WHEREAS**, Webb County and the City of Laredo have entered into that certain Agreement between the parties relating to the initial temporary closure and eventual abandonment of an approximately 1.3 mile and/or 6,250.00 linear ft. section of Wormser Road by Webb County; and Wormser Road shall be annexed and incorporated into city limits and have the City of Laredo to take over the jurisdiction, control and maintenance of this public road; and,

**WHEREAS**, on June 12<sup>th</sup>, 2023, the Webb County Commissioner's Court approved the temporary closure and re-alignment of an approximately 1.3 mile and/or 6,250.00 linear ft. section of Wormser Road due to ongoing roadway construction; see Exhibit "A";

**WHEREAS**, residents of Webb County impacted by the proposed road closures signed individual petitions requesting their closure, and all closures were posted on-site and at the Webb County Courthouse for the required 20-day notice period; and,

**WHEREAS**, the Webb County Commissioners Court finds the statutory notice provisions in Chapter 251 of the Texas Government Code have been satisfied, that to the extent required, replacement roads have been designated and readied, and hereby authorizes the temporary closure, re-alignment, re-routing, altering, of approximately 1.3 miles and/or 6,250.00 linear ft. section of Wormser Road, or portions thereof, as shown on Exhibit "A", and/or identified in this Order.

**NOW THEREFORE, BE IT HEREBY ORDERED BY THE WEBB COUNTY COMMISSIONERS COURT THAT:**

The following roads and bridges, or portions thereof, are temporarily closed, re-aligned and/or re-routed:

**Precinct No.#      Temporary Road Closure**

1. Worsmer Road approximately 1.3 miles and/or 6,250.00 linear ft. section as further shown on map attached hereto as Exhibit "A".
