This letter shall constitute our approval of the Right to Use the warehouse property (or sections of) for said purpose, consistent with Lease Agreement dated August 10, 2022.

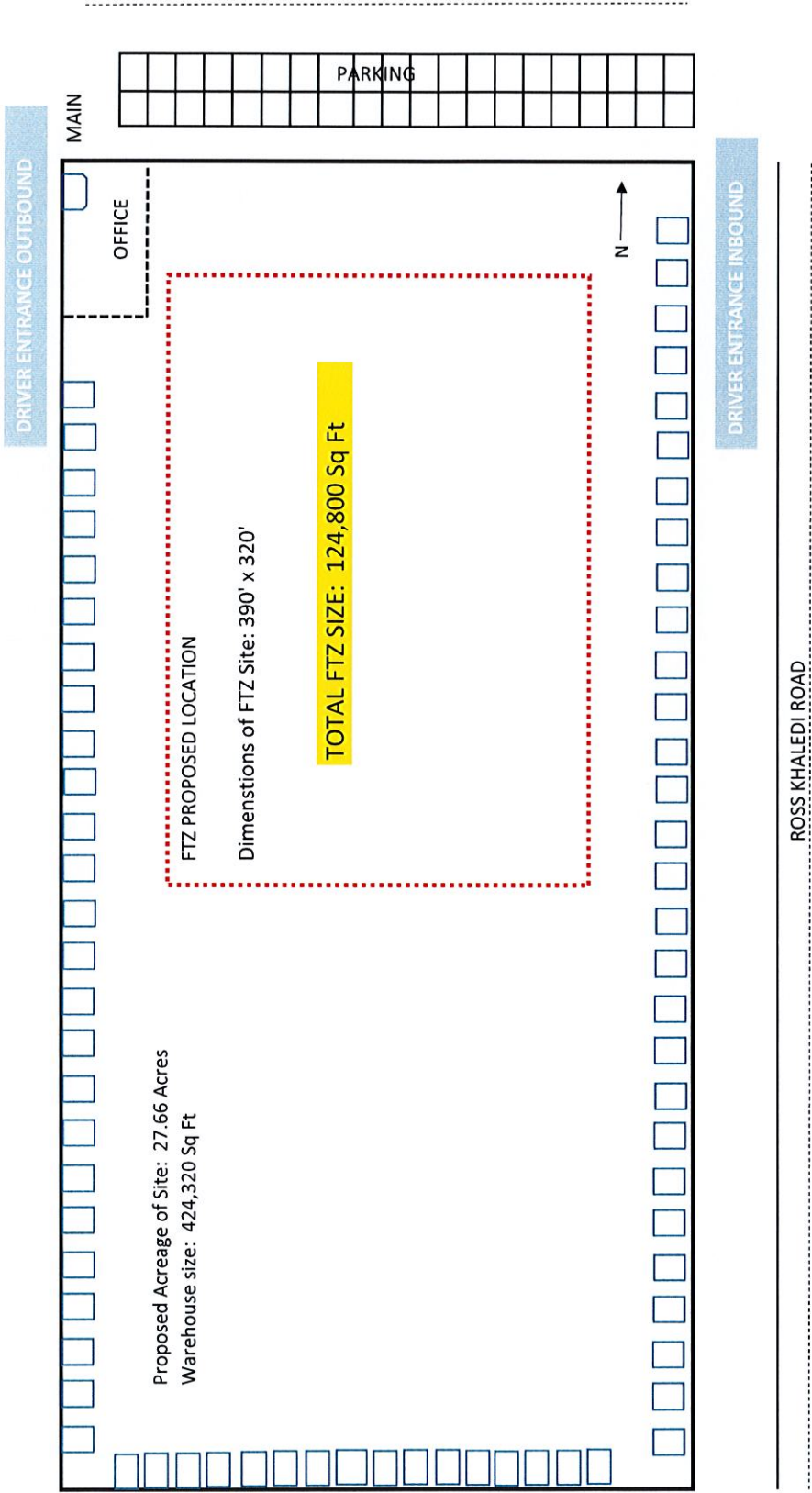
