**Solution:** Consideration to approve award to sole respondent.

**Result:** If approved, Civil / Legal Department will negotiate the terms, conditions and related fees for approval and execution of service agreement by Commissioners Court.

Discussion and possible action to approve the execution of the "Webb County Fairgrounds – Promotion Management Services Agreement" with sole proposer G&G Promotions, as per prior award of (RFP) 2023-0002, for a two year (2yr.) term commencing November 20, 2023, as per the terms and conditions set forth therein; and authorizing the Webb County Judge to sign all relevant document and any other matters incident thereto. **[Account #2031-1010-001-432001 (Webb County Fairgrounds - Professional Services)]**

**Issue:** One (1) sealed proposal was submitted in response to this public solicitation for promotion management services at the Webb County Fairgrounds facility.

**Solution:** Consideration to approve the execution of the "Webb County Fairgrounds – Promotion Management Services" agreement with sole proposer G&Gm Promotions, as per prior award of (RFP) 2023-002.

**Result:** If approved, they will begin operations on November 20, 2023, upon approval of the service agreement by the Webb County Commissioners Court.

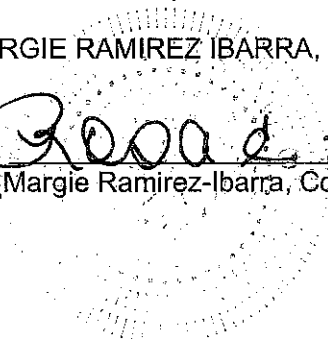

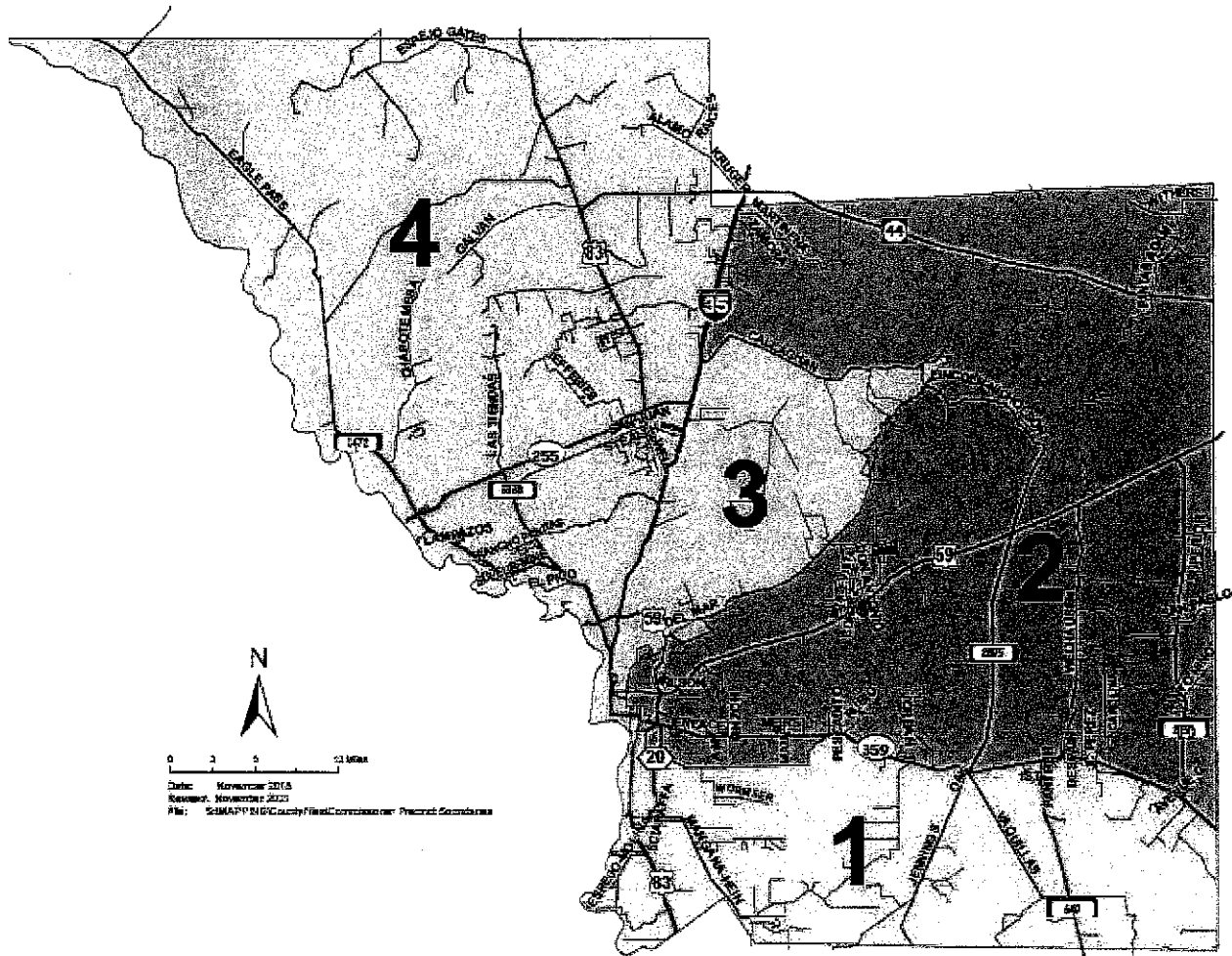
