Memorandum of Understanding

The present memorandum of understanding is entered between Border Region Behavioral Health Community Center, hereafter referred to as Border Region, Serving Children and Adults in Need Inc. hereafter referred to as SCAN and Webb County Court at Law #2. The purpose of this memorandum is to integrate mental health and substance abuse treatment services for Webb County Juvenile Drug Court participants with mental health and substance use disorders in a project funded by SAMHSA-CSAT.

Border Region Agrees to:

1. Provide mental health services to Juvenile Drug Court participants, according to Border Region's admission criteria and capacity.

2. Coordinate treatment services with SCAN of those Juvenile Drug Court Participants with co-

occurring mental health and substance use disorders.

- 3. Provide the court, if funded, with support in the implementation of the SAMHSA CSAT by attending stakeholder meetings and provide input on the implementation/operation of the
- 4. Provide brief progress reports to the court regarding participants' progress and compliance SCAN Agrees to:

1. Provide substance abuse treatment services to Juvenile Drug Court participants,

2. Coordinate substance abuse treatment services with Border Region of those Juvenile Drug

Court Participants with co-occurring mental health and substance use disorders.

3. Provide the court, if funded, with support in the implementation of the SAMHSA CSAT by attending stakeholder meetings and provide input on the implementation/operation of the court.

The Webb County Court at Law #2 agrees to:

1. Refer to SCAN and Border Region those Juveniles Drug Court Participants who may have co-occurring disorders for screening and assessment and

2. Coordinate with SCAN and Border Region the access to treatment of juveniles identified with

co-occurring disorders

3. Ensure that the Juvenile Drug Court address the 16 Key Elements of a Juvenile Drug Courts, utilize best practices in the operation of the Court and comply with all grant requirements, including reporting requirements.

4. Elicit input from SCAN and Border Region in the implementation SAMHSA-CSAT in order to

enhance and expand treatment services for Juvenile Drug Court participants

Term and Termination:

The terms of this cooperative working agreement shall begin February 25, 2014 and end September 30, 2017.

Amendment and Modification:

This agreement may be amended by the mutual agreement of the parties hereto in writing, to be attached and incorporated into this agreement.
