In reference to the attached pink form for Ms. Andrea Morales, we recognize that Ms. Morales is a current Webb County Employee under the Ernesto J. Salinas Community Center and worked on 10/17/2014 for 8 hours at the Center before commencing temporary employment as an Early Voting Election Clerk. Her temporary elections employment commenced on 10/20/2014 and ran through 10/31/2014 while on approved leave from the Community Center.

However, Ms. Morales requested 40 hours of annual leave be paid to her for 10/20/2014 through 10/24/2014 in addition to her temporary elections employment pay. This action may constitute double payment, we are hereby requesting that the annual leave hours not be paid out until which time the appropriateness of her request is determined.

We also inform that the fact the employee physically worked at the Community Center on 10/17/2014 for 8 hours may require your office to conduct a weighted average calculation review.
