***ORDER ADJUSTING BUDGET TO CONFORM TO ANNUAL COMPENSATION FOR COUNTY AUDITOR
AND ASSISTANT AUDITORS, AND ADVISING DISTRICT JUDGES
OF COMPLIANCE WITH §111.013, 111.044 AND 111.074
OF THE TEXAS LOCAL GOVERNMENT CODE***

Whereas, the Commissioners Court has received the Order Approving the Annual Compensation for County Auditor and Assistant Auditors from the District Judges of Webb County, Texas, in conformity with §152.905 of the Texas Local Government Code; and

Whereas, some of the proposed salaries for certain Assistant Auditors would include an increase that exceeds five (5) percent above the salaries of those positions in the current fiscal year; and

Whereas, Sections 111.013, 111.044, and 111.074 of Local Government Code provides that an increase in the salary of an assistant auditor shall not exceed five (5) percent from one fiscal year to the next without approval of the Commissioners Court; and

Whereas, the Commissioners Court does not support an increase exceeding five (5) percent for these positions;

Therefore, it is hereby Ordered that the annual compensation for County Auditor and Assistant Auditors shall be included in the Webb County Budget as ordered by the District Judges, except that the compensation for the following positions and persons shall be reduced to the amounts stated below to limit the increase in compensation for these positions to five (5) percent as provided by Sections 111.013, 111.044, and 111.074 Texas Local Government Code:
