THIS AMENDMENT is made by and between the State of Texas, acting through the Texas Department of Transportation, called the "State", and Webb County Community Action Agency, called the "Transit Provider".

WHEREAS, the State and the Transit Provider executed a project grant agreement on September 8, 2014; and,

AGREEMENT

1. Description of Amended Items

This amendment revises the maximum amount payable to include the residual funds from the Transit Provider's Fiscal Year 2014 project grant agreement for State funds. The revised maximum amount payable without modification under ARTICLE 3. COMPENSATION is \$309,386.85.

Attachment B, hereto attached, is the revised Project Budget and shall replace the Project Budget in said agreement.

All other provisions of the original project grant agreement not amended are unchanged and remain in full force and effect. This amendment becomes effective on the later date of full execution by both parties.
