

ORDER
WEBB COUNTY COMMISSIONERS COURT
WEBB COUNTY, TEXAS

WHEREAS, the County Judge's Executive Administrator and Commissioners Court Administrator were designated county budget officers by the Commissioners Court on March 9, 2015; and

WHEREAS, an unusual or unforeseen circumstance and condition now exists regarding the availability of certain line items in the 2014-2015 fiscal year budget to allow for payment of a salary supplement (stipend) for work associated with the duties and responsibilities of county budget officer that was approved by the Webb County Commissioner's Court on May 26, 2015; and


WHEREAS, the Webb County Commissioner's Court on May 26, 2015, declared an emergency for purposes of authorizing an emergency expenditure as an amendment to the current county budget under §111.070 of the Texas Local Government Code therein amending the 2014-2015 fiscal year budget to reflect the following:


The Webb County Commissioner's Court **ORDERS** that a salary stipend line item be created in the County Judge's Office- Department No. 200 for Slot #2828 and Commissioners Court Department- Department No. 0101 for Slot #0067 with further action to allocate funds in an amount that will allow the bi-weekly payment of a salary stipend not to exceed TWENTY-FIVE THOUSAND AND DOLLARS (\$25,000.00).

TWENTY THOUSAND (\$20,000.00) will be allocated for Slot #2828 and FIVE THOUSAND (\$5,000.00) for Slot #0067, effective May 26, 2015 from Contingency Fund Account #001-0109-6203-3 for the payment of said stipend as calculated therein. The stipend amounts will be annualized and prorated for the remainder of fiscal year 2014-2015, which ends on September 30, 2015.


THIS ORDER shall be effective immediately upon approval.


