WHEREAS, the Laredo/Webb County Community Health and Workforce Needs Assessment completed in 2011 through a collaboration of the Blue Ribbon Committee of the City of Laredo and Webb County on Health Issues, the Mid Rio Grande Border Area Health Education Center (AHEC), City of Laredo Health Department (CLHD) and the University of Texas Health Science Center San Antonio (UTHSCSA); and


