

## RESOLUTION AND ORDER

**AUTHORIZING AND APPROVING MODIFICATIONS TO THE 2016 PRIMARY ELECTION EARLY VOTING SITE RESOLUTION PREVIOUSLY APPROVED BY COMMISSIONERS COURT FOR THE MARCH 01, 2016 JOINT PRIMARY ELECTIONS WITHIN WEBB COUNTY, TEXAS, PURSUANT TO CHAPTER 85, TEXAS ELECTION CODE.**

**WHEREAS** the Commissioners Court approved the 2016 Primary Election Early Voting Site Resolution on their regular meeting of January 11, 2016; and


**WHEREAS** the Commissioners Court of Webb County, Texas desires to replace said site in order for voters to exercise their right to vote at another site;
