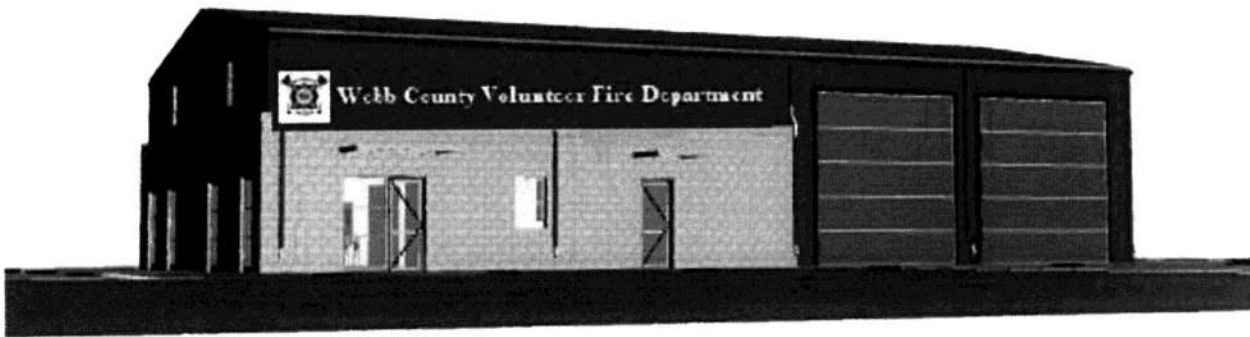

## Department Funding

Grants / TFS Appropriation / Operating Budget

FY 2015-2016 Operating Budget  
\$1.5 million

SAFER (Staffing for Adequate Fire and Emergency Response Grant)

\$256,580 - for the recruitment and retention of volunteer firefighters, this includes training.  
Grant ends March 2016

CDBG (Community Development Block Grant)

\$297,760 - for the purchase of two brush trucks.

A Quick-Attack unit was delivered January 5<sup>th</sup>, 2016. This is a 2016 Ford F550, 4x4, which was purchased for \$122,647.15. This unit will serve as a primary response vehicle out of the future Botines fire station. A large brush truck is expected to be delivered in late February, 2016.

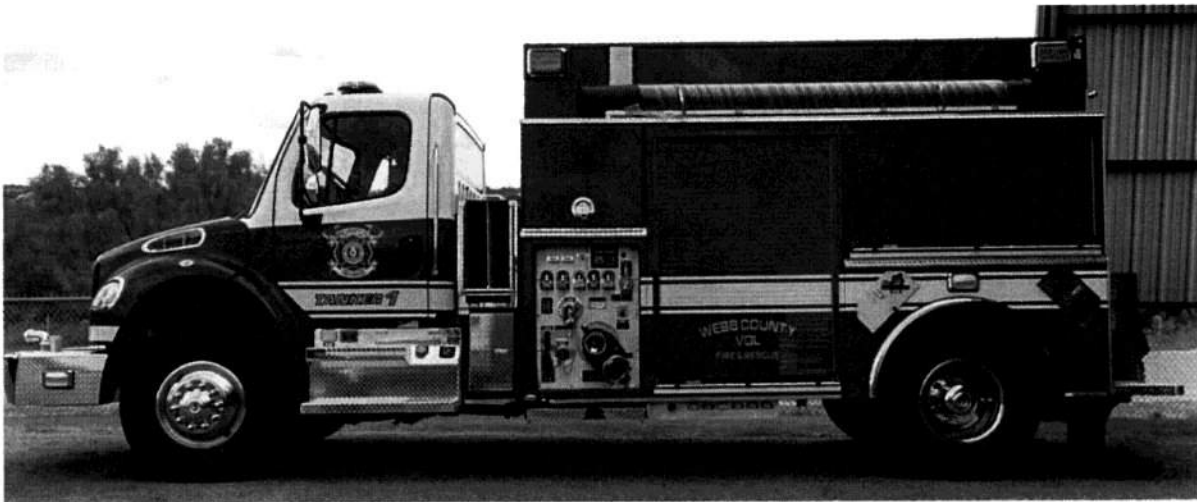


## Department Funding – Continued

Texas Forest Service Appropriation

\$1.5 million - for the purchase of firefighting equipment to include but not limited to rescue equipment, communications, personal protective gear, and vehicles.

## Los Botines Fire Station

Land acquisition arrangements for the construction of a fire station on HWY 83 north was granted Commissioner's Court approval on May 11, 2015; four (4) acres were donated by Mr. Gene Walker, Jr. This project has the impetus from Los Botines residents as well as their neighborhood association. The location is prime due to proximity of additional subdivisions such as Bonanza Hills and Four Points, and faster access to IH 35 and Camino Colombia toll road, and HWY 44.

## New Ambulance Acquisition



Webb County Fire has begun the purchase process for a new ambulance to serve out of the Quad City fire station. This mobile intensive care unit will be utilized to primarily serve the Oilton, Mirando City, Aguilares, and Bruni areas of Eastern Webb County. This purchase was made possible through funds provided by a tax abatement agreement between Webb County and Javelina Wind Energy, in the amount of \$150,000.

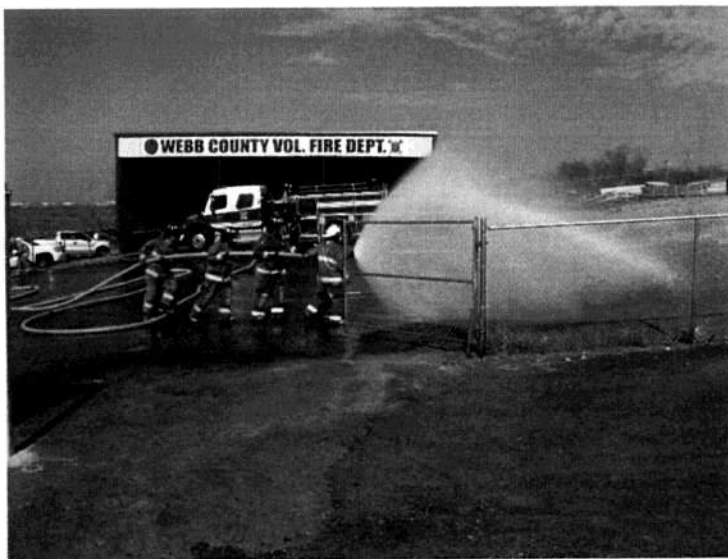


## Personnel Training

The department strives to give all incoming personnel, paid and volunteer adequate training to ensure a safe and efficient work environment. With the aid of grant monies volunteer personnel were permitted to attend regional trainings to obtain their Texas Commission on Fire Protection certification; others continued working towards this goal at the annual TEEEX Municipal Fire School. As well, local trainings are held quarterly for new volunteers, and as refreshers for actively participating staff.
